Minutes of 100th meeting of the Approval Committee constituted in terms of Section 13 of Sub Section 1 of the Special Economic Zone Act, 2005 held on 22.03.2018 at 11.00 AM in the Chamber of Development Commissioner, Falta Special Economic Zone 4th Floor, 2nd MSO Building, Nizam Palace, 234/4., AJC Bose Road, Kolkata-700 020 regarding Falta SEZ, Manikanchan SEZ, Wipro IT/ITES SEZ & IT/ITES SEZ units in Candor Kolkata One Hi-tech Structures (P) Ltd., M/s. M.L. Dalmiya & Company Ltd., TCS Ltd. and DLF IT/ITES SEZ, Kolkata. List of participants is enclosed at Annexure-I.

The Zonal Development Commissioner welcomed the Members of the Committee. The Committee was informed that no reference against the decisions of the Approval Committee held on 27.02.2018 was received from any member of the Committee or trade and therefore, minutes of the meeting held on 27.02.2018 was taken as confirmed in the meeting.

**Agenda Item No.1:** Request for renewal of LOP (No. FEPZ/LIC/L-18/2007/2409 dated 24.08.2007) for a further period of five years beyond 31.03.2018 of M/s. Linc Pen & Plastics Ltd.

The request of M/s. Linc Pen & Plastics Limited for renewal of LOP for a further period of 05 years was discussed in the meeting. Shri N.K. Dujan & Shri Rohit Malani represented on behalf of their unit and deliberated their request before the committee.

After deliberation the committee approved renewal of LOP for a further period of 5 years beyond 31.03.2018 in terms of provision of Rule 19(6) of SEZ Rules, 2006.

**Agenda Item No.2:** Proposal for inclusion of new items viz. Flexible Intermediate Bulk Containers [FIBC] under ITC (HS) Code No.63053200 in the existing Letter of Permission (LOP) No. FEPZ/LIC/S- 45/99/4493 dated 10.08.1999 of M/s. Sai Industries Private Limited, SEZ Unit located at Shed No. I in Sector-I, at Falta SEZ, Falta.

The matter was discussed in the meeting. Shri Anand Jeloka on behalf of M/s. Sai Industries Pvt. Ltd. appeared and deliberated his request before the committee.

After deliberation the committee approved for inclusion of additional items Flexible Intermediate Bulk Containers [FIBC] under ITC (HS) Code No.63053200 in terms of provision of 1st proviso of Rule 19(2) of SEZ Rules, 2006.

**Agenda Item No.3: Inclusion of Semi finished garments in LOP – request thereof-M/s. A.P. Fashions Pvt. Limited, a SEZ unit located at Falta SEZ, Falta.**

The matter related to inclusion of Semi finished garments of cotton under ITC (HS) Code No.62046200 in the existing valid LOA was discussed in the meeting. None appeared before the committee.

During the course of discussion the concerned Specified Officer has informed the committee that the said unit was applied for relaxation in one time measure as a special case but they have-not performed properly.

After deliberation the committee decided that the unit may be advised to clarify their request since inclusion of items as a semi finished garments of Cotton which is not a finished product and also decided to give them an opportunity for a personal hearing before the next UAC members.

**Agenda Item No.4: Validity of extension of Letter of Approval No. FSEZ/LIC/L-24/2016/80 dated 04.04.2016 in respect of M/s .Ludlow Jute & Specialties Ltd which will expire on 03.04.2018.**

The request of M/s. Ludlow Jute & Specialties Limited for renewal of LOP for further period of 01 year beyond 03.4.2018 was discussed in the meeting.

The committee observed that the FSEZ Authority was not in a position for allotment of open land to the said unit due to non settlement of 30 years renewal of Lease Agreement recently extended by KOPT. However, after deliberation the committee decided to grant for extension of validity of LOP for a further period of one year beyond 3.4.2018 with the existing terms and conditions of LOP. It was also decided all the pending proposals for allotment of land along with availability of land should be placed in the next UAC.

**Agenda Item No.5: Approval of list of materials submitted by M/s. Candor Kolkata One Hi-Tech Structures Pvt. Limited, New Town, Rajarhat,Kolkata.**

The said matter was discussed in the meeting. The representative of the Developer also appeared and deliberated his request before the committee.

The committee noted items of materials viz. Housekeeping, Horticulture, Security, Fire and Safety etc. along-with approx quantity and value, duly certified by the Chartered Engineer for maintenance job inside the SEZ premises.

After deliberation the committee approved the list of said materials in terms of provision in Rule 12(2) of SEZ Rules, 2006 subject to compliance of provision in Rule 12(6) & (7) of SEZ Rules, 2006.

**Agenda Item No.6** Allotment of Land to M/s Precision Polyplast Pvt. Ltd., a SEZ unit located at Falta SEZ, Falta.

The matter was discussed in the meeting and it was decided that all the pending proposals for allotment of land along with availability of land should be placed in the next UAC.
