Shri G.Seetharam Reddy, Chairman & CEO welcomed all the members present in the meeting and requested Dr. Sriramappa V, Dy. DC, Falta SEZ to place the agenda before the Committee for discussion.

Item wise decisions taken were as under:

Agenda Item No. 01: Ratification of the minutes of 103rd UAC meeting held on 26/06/2018.

Minutes of the 103rd UAC meeting was circulated to all the members. As no comments were received, the committee ratified the minutes and confirmed the same.


Agenda Item No. 2: Request of M/s. United Sales Agency for Inclusion of new items i.e. Clothing Hanger in their existing LOP No. FSEZ/LIC/U-14/2006/3282 dated 31.8.2006 .

Mr. Subir Ghosh, the partner of the unit appeared before the committee and presented Unit's proposal.

After deliberation, the Committee approved **Inclusion of Clothing Hanger** in their existing LOP subject to achieving positive NFE for this item individually & separately with proper accounting of imported items. Further, DTA sale are not permitted and only export of imported item is permitted for trading purpose.

Agenda Item No.2: Request of M/s. DLF SEZ Limited for **withdrawal of Permission for procurement of goods for carrying out Authorized Operations purpose**

The committee **noted** the withdrawal of their earlier request of Permission for procurement of goods for carrying out Authorized Operations, which was deferred in 103rd UAC held on 26.6.2018.

Agenda Item No.1: Inclusion of items in LOP and enhancement of production capacity of M/s. Himadri Specialty Chemicals Limited.

Discussed the request of M/s. Himadri Specialty Chemicals Limited for inclusion of additional items in their existing LOP and enhancement of production capacity which was deferred in 103rd UAC held on 26.6.2018, again in this meeting.
