Shri G.Seetharam Reddy, DC & Chairman welcomed all the members present in the meeting and requested Dr. Sriramappa V, Dy. DC, Falta SEZ to place the agenda before the Committee for discussion.

Item wise decisions taken were as under:

Agenda Item No. 01: Ratification of the minutes of 105th UAC meeting held on 27.08.2018

Minutes of the 105th UAC meeting was circulated all the members. As no comments were received, the committee ratified the minutes and confirmed the same.

Agenda Item No.02: Application of M/s. United Cycle Co. for setting up of new unit under SEZ Scheme for manufacture and export of Bicycle, E- Bicycle, & Accessories in Falta SEZ

Discussed the matter of M/s. United Cycle Co. for setting up of a new unit under SEZ Scheme, for manufacture and export of E-Bicycle, Bicycle & Accessories for 100% exports at Falta SEZ.

Mr Subir Ghosh the representative of the unit appeared before the committee and explained the case for consideration.

After due deliberation the committee decided to defer the matter for the next UAC meeting with a direction to the entrepreneur to submit a revised proposal with a clear & complete details including the space required. Mean while SEZ authority to look into the suitability of space for the above activity, in the industrial shed as applied for.

Agenda No. 3: Application of M/s. Capgemini Technology Services India Limited for setting up of a SEZ unit at Candor Kolkata One Hi-tech structures Pvt Limited IT/ITES SEZ Located at Rajarhat, Kolkata.

Discussed the matter of M/s. Capgemini Technology Services India Limited for setting up of a new unit of IT/ITES at Candor Kolkata One Hi-Tech Structures Pvt Ltd IT/ITES Rajarhat, Kolkata. The representative of the unit concerned Mr. Ramakrishna Menon explained the case.

After deliberations the Committee approved the proposal provisionally subject to Joint inspection report of the Factory to the UAC by SEZ, Customs & Industry Dept. Officials to see the existing manufacturing process, capacity enhancement and the systems in place for adherence to the product technical specifications of raw material & finished products.


