All concerned are hereby informed that as per directions of Central Government, EPCES has started the process to conduct elections of Vice-Chairman, Central Governing Council and 7 Regional Vice-Chairman and 7 Regional Governing Councils of EPCES through E-voting in accordance with provisions contained in Para 2.92 of the Handbook of Procedures of Foreign Trade Policy 2015-20. The Development Commissioners of the respective SEZ have been nominated as the Returning Officers for conducting the above said elections. The election schedule is given below:
