The 1st Meeting of the Unit Approval Committee for EOUs, for setting up EOUs in Odisha, held on 11.06.2021 through video conferencing. The Officers attended the Meeting is at Annexure-I.

2. Dr.B.K.Panda, Zonal Development Commissioner, FSEZ & Chairman of UAC for EOUs welcomed all the Members attended the meeting.
3. The Agenda taken up for discussion was as under.

Agenda Item No. 2021-22/ 1: Application of M/s. Subhadra Traders Pvt. Ltd., for setting up a 100% EOU at Hotel Park Building, Opp. Mangal Bhavan, Main Road, Rourkela- 769001, Odisha.

M/s. Subhadra Traders Pvt. Ltd., has submitted an application on 07.05.2021 enclosing application in ANF-6A along with related documents for setting up of a 100% EOU at Hotel Park Building, Opp. Mangal Bhavan, Main Road, Rourkela769001, Odisha. After due examination, the said proposal was placed before the UAC for consideration.

The representative of M/s Subhara Traders Pvt Limited explained the Business Plan and how to achieve the target for NFE and requested to issue the LOP.

During deliberation Shri Debjyoti Chakravarty, Addl. Commissioner, Rourkela CGST Commisionerate pointed out that as the setting up a 100% EOU Unit is a very sensitive issue, physical verification of the address and the credentials of the firm has to be obtained from various department like Directorate of Revenue Intelligence (DRI), Director General of Commercial Intelligence (DGCI) and Director General of GST Intelligence (DGGI) and others too. They have already initiated the process and it may take at least one month time to get all the feedback from those Authorities. Therefore, he suggested that the decision for issuing LOP may not be taken up in this UAC meeting. It may be decided in the next UAC meeting to be scheduled after one month.

After detailed deliberation, the Committee decided to defer the proposal for the next UAC to be held after one month.
