The land owner Smt. Lakshmi Agarwal has accepted that she has rented the premises (Godown) at the aforesaid address of M/s. Subhadra Traders Pvt. Ltd The premises is constructed in the form of Godown and the premises/Godown was closed and no activity was going on during verification due to corona Pandemic as the land owner.

Observation:-

1	Physical Verification- The premises is a Go-down premised on rental basis		
2	Financial Capabilities of the Promoters needs to be verified by Falta SEZ looking at the capital introduction v/s projected Turnover.		
3	Antecedents – so far nothing adverse report received from DRI/DGGI/ED etc.		
4	Business experience and history or promoters in other companies where they are Directors needs to be checked at the end of Falta SEZ.		

The Joint Director, DGFT has also the same comments at par with the Addl. Commissione CGST, Rourkela Commissionerate.

Thus, the Committee has decided to defer the proposal for the next meeting. However, before thematter is placed in the next UAC Meeting, specific comments on the issue may be obtained from the proposed unit/other bodies.
