Sub: Minutes of the 6th meeting (2nd meeting of 2023 series) of the Unit Approval Committee (UAC) for Export Oriented Unit (EOU) held on 13.11.2023 through Hybrid mode under the chairmanship of Shri Satish Kumar, Zonal Development Commissioner, Falta SEZ.

Agenda No. 1: Application of M/s Worldwide Safety (P) Ltd. (Unit-III) for setting up new 100% EOU unit at Kolkata Leather Complex, Zone-9, 24 Parganas South, Pin-743502, West Bengal.

The proposal of M/s Worldwide Safety Pvt. Ltd. (Unit-III) for setting up new 100% EOU unit was discussed and examined in detail by the Committee. Shri Prashant Tulsyan, Director, Authorized Representative of the Company, physically appeared before the Committee and requested to consider the proposal.

The Committee considered the agenda under the light of Para 6.05(a)(i) of Foreign Trade Policy 2023 and Para 6.01(b)(i) of Hand Book of Procedures 2023.

Committee observed that the application in ANF-6A is in order. Committee noted, the item of export (Seamless Knitted Gloves with Leather Patch / ITC(HS) Code: 61169990, Leather Gloves with Seamless Knitted Lining / ITC(HS) Code: 42032910, Leather Gloves / ITC(HS) Code: 42032910, Textile Gloves(Cut & Sewn) / ITC(HS) Code: 62160090), projected Net Foreign Exchange earnings for five years amounting to Rs. 5640.00 lakhs, proposed investment and KYC details of the company as provided in the application.

After deliberations, Committee approved the proposal of M/s Worldwide Safety Pvt. Ltd.(Unit-III), for setting up a new 100% EOU unit at Kolkata Leather Complex, Zone-9, 24 Parganas South, Pin-743502, West Bengal subject to the following conditions:

- The proposed items will be subjected to fulfillment of conditions as indicated in ITC(HS) classification of Export and Import items.
- In case of any discrepancies/mismatch between the 'HSN code/Description of Goods' as provided by the unit and 'HSN Code/Description of Goods' as per ITC (HS) classification of Export and Import items, the later will prevail.
- If in future any of the items becomes restricted/prohibited as per ITC (HS) classification of Export and Import items, then such items shall get excluded from the LOP.

Agenda No. 2: Request for inclusion of additional items viz. “Herbal Infusions (Rooibos/Chamomile/Rosehip & Hibiscus TBC/Peppermint & Ginger TBC)-Bulk/Packet/Tea Bags form” and promotional materials in the existing LOP dated 24.03.2000 of M/s Premier’s Tea Pvt. Ltd. a 100% EOU under the jurisdiction of Falta SEZ, in addition to the existing items of manufacture and export.

The request of EOU M/s Premier’s Tea Pvt. Ltd for inclusion of (i) additional items and (ii) promotional materials in their Letter of Permission (LOP) was discussed and examined in detail by the Committee. Shri R. Srinivasan, Executive Director (Operations & Administration), Authorized Representative of the Company, physically appeared before the Committee and requested to consider the proposal.

- (i) The Committee considered the request for inclusion of additional items under the light of Para 6.34(e) of Hand Book of Procedures 2023.

Committee observed that the unit achieved positive NFE in the last five FYs, and noted the employment details as provided in the application.

After deliberations, the Committee approved the proposal of M/s Premier’s Tea Pvt. Ltd. for inclusion of additional items i.e Herbal Infusions (Rooibos/Chamomile/Rosehip & Hibiscus TBC/Peppermint & Ginger TBC) – Bulk/Packet/Tea Bags form / ITC(HS) Code: 12119090 in their existing LOP No. 2(1)/P-7/2000/14193 dated 24.03.2000 subject to the following conditions:

- (a) The proposed items will be subjected to fulfillment of conditions as indicated in ITC(HS) classification of Export and Import items.
- (b) In case of any discrepancies/mismatch between the ‘HSN code/Description of Goods’ as provided by the unit and ‘HSN Code/Description of Goods’ as per ITC (HS) classification of Export and Import items, the later will prevail.
- (c) If in future any of the items becomes restricted/prohibited as per ITC (HS) classification of Export and Import items, then such items shall get excluded from the LOP.

- (ii) The Committee observed that the proposed items namely Glass Tea Pot/Glass Cup & Plate/Glass Mug & Plate/Glass Jar & Lid/Glass Warmer and Porcelain Tea Pot/Cup & Plate are not promotional material as per provisions of Para 6.1(c) of Foreign Trade Policy 2023.

After deliberation, Committee decided that the said items shall be dealt as per provisions of Para 6.4 of Handbook of Procedures 2023 (Import/Domestic Procurement of Goods).
