





# **Welcomes Investors**

With the river Hooghly flowing on its West, Falta SEZ has been developed over an area of 273 acres of land on an ideal location in the District South 24 Parganas in a Pollution free environment. The zone is under the administrative control of the Ministry of Commerce & Industry (Department of Commerce), Government of India, New Delhi. It is the largest multi-sector Special Economic Zone in the eastern and north-eastern prosperous hinterland extending to the States of West eastern States endowed with vast mineral resources products; leather, ceramic and glas industries etc. The Zone, located in a Pollution free environment, has at a distance of 55 Kms. From Kolkata.

- 24 hours water supply is ensured through a well-knit distribution system within the Zone @ Rs.10/- per 1000 litres.
- Container Handling letty is available in Sector-III.
- Setting up of ICD is under process.
- Skilled labours are available in and around the Zone.
- Banking/Postal service are available in and around the zone.
- Residential Flats for Industrial Units are available.
- Fire Station services available at door-step.

# Incentives available at FSEZ

The Government of India introduced the Special Economic Zone scheme on 01.04.2000. The scheme has been extended to Falta SEZ since 01.01.2003. The salient features of SEZ scheme are:

- Units can be setup for manufacturing, trading or service activity.
- Exemption of Custom/Excise duty on capital goods, raw materials, consumables, spares and building materials etc.
- Units to be positive foreign exchange earners within 5 years.
- Domestic sales of manufactured goods on full duty subject to import policy in force.
- No fixed wastage norm.
- Sub-contracting in DTA and abroad exporters for direct export allowed.
- Depreciation upto 100% is permissible for computer and computer peripherals in five years and in case of other capital goods in ten years.






- 100% Foreign Direct Investment allowed through automatic route in manufacturing sector.
- Service Tax exemption, consumed within zone.
- Facility to Keep 100% export proceeds in EEFC Account and freedom to make overseas investment from it.
- 100% Income Tax exemption for a first block of 5 years, 50% tax exemptions for next block of five years and for the next five years on plough back profit under Section 10AA of Income Tax Act.
- In-house Customs Clearance.
- Exemption from customs/Excise duty on goods (all construction materials) for setting up and maintenance of units in zone.
- Export and Import is on self-declaration basis.
- No routine examination by Customs for export and import cargo.

# How to apply at the Zone

Provision for filing application for new unit via online at www.sezonline-ndml.co.in/www.fsez.nic.in

A consolidated application in Form F in terms of para 17 of SEZ Rules, 2006 should be submitted to the Development Commissioner, Falta Special Economic Zone in 5 copies along with project report and a payment of Rs. 5000/- (Rupees Five Thousand) through Bharatkosh in favour of RPAO (Commerce), Kolkata. The following documents shall accompany the application:

- Proof of residence, namely, passport or ration card or driving licence or voter identity card or any other proof of the proprietor or the partners of the partnership firms or Directors of the company, as the case may be, to the satisfaction of Development Commissioner.
- Income tax returns, along with annexure, of the Proprietor or partners, or in the case of a company, audited balance sheet for the last three years.
- Experience of the Promoters / Directors, marketing tie-ups etc.
- . E.mail ID of the firm / Chief Executives.
- · Website address of the firms.

Projects are approved and a Letter of Approval (LOA) is issued by the Development Commissioner, FSEZ within 7 days of receipt of complete application.
