Shri B.K. Panda, Chairman & CEO welcomed all the members present in the meeting and requested Shri M.K. Anjanaiah, Dy. DC, Falta SEZ to place the agenda before the Committee for discussion.

Item wise decisions taken were as under:

Agenda Item No. 01: Ratification of the minutes of 111th UAC meeting held on 27.02.2019

Minutes of the 111th UAC meeting was circulated all the members. As no comments were received, the committee ratified the minutes and confirmed the same.

Agenda Item No.2: Application for setting up of a SEZ unit for manufacture of PP Bag with/without liner, PP Fabric, Technical Textile & Flexible Intermediate Bulk Containers(FIBCS) at Falta SEZ, Falta.



Subject: Exit of M/s Jewel India Private Limited from Manikanchan SEZ – regarding.

M/s Jewel India Private Limited has applied for exit from Manikanchan Special Economic Zone. The Module earlier possessed by them i.e. Module No. G-NE (1) of Manikanchan SEZ, has been handed over to M/s. S.B. Creations by WBIDC vide letter No. WBIDC/IP/MK/SDF/Module/G-NE (1)/504 dated 27.11.2018.

2. Specified Officer (Customs), MKSEZ have issued a No Objection Certificate to M/s Jewel India Private Limited vide letter No. MKSEZ/CUSTOMS/BOND-JI/06/2005/123 dated 22.02.2019. They have also submitted a Legal Undertaking for Exit from Manikanchan Special Economic Zone in Form L on 29.04.2019.
3. Before processing the case for de-bonding of the Unit from Manikanchan SEZ, the following points need to be noted:-
 - i. The Unit got LOP vide this office letter No. MSEZ/LIC/J-1/2004/7278 dated 10.01.2005. The date of commercial production of the Unit is 22.03.2007. During FY **2007-2008**, the Unit exported to the tune of **Rs.161.75 lakhs** only. After that there was no performance from the Unit. The validity of LOP was extended upto 31.12.2015 vide letter No. MKSEZ/LIC/J-1/2004/1232-34 dated 24.07.2015. The performance of the Unit (1st Block-2008-2009 to 2012-13 and 2nd Block-2013-14 to 2014-15) was monitored upto 2014-15 in the 81st UAC meeting held on 29.03.2016. It was decided in that Meeting to issue a Show Cause Notice for no EXIM performance of the Unit for the last 7 years and for cancellation of LOP. The office issued a Show Cause notice dated 08.04.2016. In response, they replied vide letter dated 20.04.2016, that they have suspended their manufacturing / export since long time due to trade recession and they have also not been informed that the validity of their LOP got extended upto 31.12.2015.
 - ii. Their reply to the Show Cause Notice was placed before the 83rd UAC meeting held on 15.06.2016. After deliberation the Committee decided that the Show Cause Notice is adjudicated by way of cancellation of LOP from the date of lapse of LOP in terms of SEZ Act & rules.
 - iii. Subsequently, the representative of M/s Jewel India Limited appeared before the appropriate authority, MKSEZ on 28.02.2017 and stated that they have made several correspondences with WBIDC for a long period to transfer their property, but WBIDC has not agreed to the proposal. After the discussion, the appropriate authority advised to submit their request for Exit from SEZ since validity of LOP has lapsed or another proposal, as deemed fit.
 - iv. Consequently, vide their letter dated 06.12.2018, M/s Jewel India Limited have applied for exit from Manikanchan SEZ. **The matter is now placed before Approval Committee for discussion/ decision.**

- Vide this office letter dated 12.11.2018, they have been requested to submit their APR for the year 2017-18, but they have not submitted the same.

M/s Rohit Export Jewellery LLP

- M/s Rohit Export Jewellery LLP has suspended their manufacturing works since 2015-16. They have not submitted their APR for the year 2015-16 and 2016-17. They have submitted their APR for the year 2017-18 where they have shown **NIL** exports. The validity of their LOP expired on **13.02.2017**. They have not applied for renewal of LOP.

M/s B.C. Sen & Co. Ltd.

- M/s B.C. Sen & Co. Ltd. has suspended their manufacturing works since 2015. After monitoring their performance for the FY 2013-14 & 2014-15, as per directions of UAC, they were requested vide this office letter dated 22.01.2016, to clarify the poor performance of export activity. In reply, vide their letter dated 03.02.2016, they have stated that earlier the Unit in Manikanchan SEZ was in the name of M/s. B.C. Sen International Ltd. As per Hon'ble High Court's Order dated 20.03.2014, M/s. B.C. Sen International Ltd. got amalgamated with M/s. B.C. Sen & Co. Ltd. This amalgamation was also approved by this office vide letter No. MKSEZ/LIC/B-1/2014/77 dated 14.08.2014.
- Subsequently, they requested WBIDC to endorse the sub-lease deed earlier made with erstwhile B.C. Sen International Ltd. in favour of the amalgamated company, M/s. B.C. Sen & Co. Ltd. Since the matter was pending with WBIDC, they have not been able to start manufacturing activities from their SEZ unit during the last 2 years.
- Instead of submitting APRs for the year 2015-16, 2016-17 and 2017-18, they have stated vide their letters that there has been no performance from their captioned Unit. The validity of their LOP got expired on **27.06.2017**. They have not applied for renewal of LOP.
- Vide this office letter dated 24.12.2018, this office requested the Unit to clarify the present status of their request to WBIDC for transfer of sub-lease of the possession in favour of amalgamated company. In response, vide their letter dated 16.01.2019, they have enclosed a letter dated **13.03.2018** from WBIDC that their Competent Authority has accepted the proposal of amalgamation of B.C. Sen International Ltd. with B.C. Sen & Co. Ltd. without imposition of transfer fees.
- Even after acceptance of the proposal of amalgamation of M/s B.C. Sen International Ltd. with M/s. B.C. Sen & Co. Ltd. on 13.03.2018, no manufacturing activities took place in their Unit till date. **The matter is placed before Approval Committee for discussion/ decision.**
