

- M/s. Midas DFS Pvt. Ltd. has been holding the LOP No. FSEZ/LIC/M-37/2004/388 dated 25.04.2005 for 'Trading and Distribution' of Cigarettes & Alcohol.
- The 138th UAC meeting held on 22.12.2021 renewed the LOP for 2 (two) years beyond 16.03.2021 subject to condition that prohibited and restricted items will not be allowed in SEZ for the purpose of any type of import. Import items should be for 100% export purpose only and the permission for renewal of LOA is subject to compliance of application formalities of any other statutory Authority as required.
- Further, the **143rd UAC** approved the proposal of the unit for inclusion of **Readymade Garments ITC(HS) Code - 6114, 62113911, 6111, 6117, 621040, 621149, 62114300, 621142**, as applied by the Unit or any other item of clothing classifiable under chapter 61 or 62 of Customs Tariff subject to restrictions on import or export under the Foreign Trade Policy and subject to compliance of SEZ Act, 2005 & SEZ Rules,2006. Further, the **154th UAC meeting held on**

25.01.2023 approved the proposal for inclusion of the items Hand Purse- ITC(HS) Code 42022990 and Mens Shoes-ITC(HS) Code 64029990.



The Unit has been issued extension of LOP for one (01) year (i.e. from 05/04/2023 to 04/04/2024) vide this Office letter dated 19.04.2023.
