Subject: Minutes of 167th meeting (10th Meeting of the 2023 Series) of the Unit Approval Committee (UAC), Falta SEZ held on 18.10.2023 through Hybrid mode under the chairmanship of Zonal Development Commissioner, Falta SEZ.

Agenda Item No. A&B: Ratification of the minutes of 166th UAC meeting held on 25.08.2023.

Minutes of the 166th UAC meeting was circulated to all the members of UAC. As no comments were received, the 167th UAC ratified the minutes and confirmed the same.

Agenda Item No.1: Request of M/s Narendra Tea Co. Pvt. Ltd., a manufacturing unit of Falta SEZ, for renewal of LOA no. FSEZ/LIC/N-15/2003/11299 dated 21.03.2003 for a period of 05(five) years w.e.f. 01.09.2023 to 31.08.2028.

Shri Shekar Samanta physically represented the unit M/s Narendra Tea Co. Pvt. Ltd before the Committee.

Committee considered the agenda under the light of Rule 19 (6A) and 19 (6B) of SEZ Rules 2006.

Committee observed that, the unit has not applied for renewal before two months from the date of expiry of the Letter of Approval as required under the rules, and therefore asked the unit to state the reason for delay. The unit stated that, due to some unforeseen circumstances in their unit they could not apply for renewal on time. The Committee noted the same and condoned the delay.

Committee further observed that, Annual Performance Report (APR) of the unit was monitored only upto year 2016-17. Committee therefore directed O/o DC, Falta SEZ to place the APRs of the unit upto year 2022-23 before UAC for monitoring as soon as possible.

Committee noted the FOREX balance sheet for the current block and for the next block, as stated by the unit in their renewal application in Form F1.

Committee asked Secretary, Falta SEZ Authority about pending lease rental dues on account of the unit, and it was informed that the unit has pending rental dues of around Rs17

1/51979/2023 akhs. The unit committed before the Committee that they would clear the pending rental dues very soon.

After deliberation, Committee approved renewal of the unit's Letter of Approval for only 02(two) years w.e.f. 01.09.2023 for undertaking the authorized operation i.e. 'Manufacturing', with the condition that the unit should comply to the provisions of SEZ Act 2005 and Rules 2006, Foreign Trade Policy and Foreign Trade (Development and Regulations) Act, 1992 as amended from time to time..

Agenda Item No.2: Cancellation of LOA of M/s. H4U Exports Pvt Ltd., a Manufacturing unit of Falta SEZ holding LOA No. FSEZ/LIC/H-15/2005/4858 dated 06.10.2005.

No one represented the unit M/s H4U Exports Pvt Ltd. before the Committee.

Committee noted that,

- The Letter of Approval of the unit expired on 25.12.2011, and the unit neither applied for renewal of the Letter of Approval nor applied for exit from SEZ.
- ii. Land/shed stands allotted against the unit.

After deliberation, Committee decided to Show Cause the unit, with an opportunity for Personal Hearing, as to why the Letter of Approval should not be cancelled w.e.f. 26.12.2011 under Section 16 of SEZ Act 2005 for contravention of SEZ Acts and Rules.

Agenda Item No.3: Cancellation of LOA of M/s Rosinate India Company, a unit of Falta SEZ holding LOA No. FSEZ/LIC/R-39/2002/10044 dated 11.03.2003.

Shri B.K. Kesan and Shri A.Dhand physically represented the unit M/s Rosinate India Company before the Committee.

Committee observed that, the unit was show caused by the 166th UAC as to why the Letter of Approval should not be cancelled w.e.f. 11.02.2006 under Section 16 of SEZ Act, 2005 for non commencement of production leading to contravention to SEZ Acts and Rules.

Committee noted the unit's reply to the Show Cause Notice, wherein the unit stated that they used to do job work/production for their sister concern from their premises and they don't have their own production.

The unit stated before the committee that they will have no objection if the Letter of Approval gets cancelled.

After deliberation, Committee decided to cancel the Letter of Approval of the unit under Section 16 of SEZ Act, 2005 w.e.f. 11.02.2006.

Shri Devesh Jain physically represented the unit M/s Ariahant Worldwide Limited before the Committee.

Committee considered the agenda under the light of Rule 19 (6A) and 19 (6B) of SEZ Rules 2006.

Committee observed that, performance monitoring of the unit is pending for some years of the last block. Committee therefore directed O/o DC, Falta SEZ to place the pending APRs of the unit upto year 2022-23 before UAC for monitoring as soon as possible

Committee noted the FOREX balance sheet for the current block and for the next block, as stated by the unit in their renewal application in Form F1.

Committee asked Secretary, Falta SEZ Authority about pending lease rental dues on account of the unit, and it was informed that the unit has no pending rental dues.

After deliberation, Committee approved renewal of the unit's Letter of Approval for 05 (five) years w.e.f. 10.10.2023 for undertaking the authorized operation i.e. 'Warehousing', with the condition that the unit should comply to the provisions of SEZ Act 2005 and Rules 2006, Foreign Trade Policy and Foreign Trade (Development and Regulations) Act, 1992 as amended from time to time.

Committee observed that, the unit in their request has stated the broad heading of the default services as mentioned in the approved list of services, instead of stating the exact services that they would like to get it approved under default services.

After deliberation, Committee deferred the matter for want of clarification from the unit.

Sub.: Cancellation of LOA of M/s Space Matrix Ltd., a unit of Falta SEZ, for gross misuse and violation of SEZ Acts and Rules and Foreign Trade (D&R) Act 1992 - regarding

M/s. Space Matrix Ltd(earlier Known as Space Matrix Agencies Pvt Ltd) was granted LOA vide letter no FSEZ/LIC/S-97/2006/3702 dated 27 /09/ 2006 for manufacture and export of PROPERITERY STORAGE OPTICAL DEVICES (inclusive Recorded & unrecorded media). The unit accepted term & conditions of LOA and executed BLUT dated 29 /11/2006. The unit started production (DCP) w.e.f. 19/12/2008. The LOA has lapsed on 18/12/2013. Thereafter unit has not requested for renewal of LOA. The unit also has not applied for exit as per SEZ Rules, thus contravening SEZ Acts and Rules.

In term of Rule 22(3), the APR submission is required within 180 days following the closing of financial year. The unit did not submit the APR for FY 2011-12, 2012-13 and 2013-14.

This unit was involved in fraud export which was investigated by DRI team after serving SCN. Later O/o Principal Commissioner of Customs(Airport & Admn) issued an Order-in-Original to the M/s Space Matrix Ltd and its Director wherein it was found that:

- (1) gross mis-declaration of quantity, value and description and thus evaded huge customs duty.
- (2) Goods attempted to export in containers were found junk and filled with foam whereas in shipping bill it was shown USB 16 GB flash Drive and CD lens
- .(3)imported duty free capital goods like High precision USB flash, printer, router were sold in DTA after clandestinely removing them from Falta SEZ.
- (4)Director of unit admitted before ED & DRI officers that his business venture was a paper exercise, where only goods of No Commercial Value(NCV) were exported or attempted to be exported in the guise of COMPUTER PERIPHERALS. The imported duty free goods were not utilized in manufacturing of export items in FSEZ since they used to remove clandestinely from FSEZ to DTA also admitted that Payment through HAWALA channel and possibility of same in achieving NFE (+Ve).

The unit since inception persistently had breached the SEZ Acts and Rules by showing misdeclaration of quantity of export & import.

Further, Debtors of the unit has gone to Hon'ble NCLT in the year 2019. Mr Soumitra Lahiri was appointed as an Official Liquidator vide NCLT, Kolkata bench Order dated 24.02.2020. Final dissolution order of NCLT is awaited.

Accordingly the sale of assets in Falta SEZ belonging to the Liquidation Estate of Space Matrix Pvt. Ltd. was done by the liquidator through e-auction held on 9th August 2023 to M/s Pacific Jute Ltd. an existing unit of Falta SZ.

In terms of Section 16(1) of SEZ Act 2005 The approval Committee may, at any time, if it has any reason or cause to believe that the entrepreneur has persistently contravened any of the terms and conditions or its obligation subject to which the LOA was granted to the entrepreneur, cancel the LOA.

Accordingly, the matter is placed before UAC for discussion/decision.
