In terms of ist Proviso of Rule 19(2) of SEZ Rules, 2006 "Provided that the approval committee may also approve proposals for enhancement of capacity of production, if it meets the requirements of Rule 18"

The Unit has intimated that as per IEM(Industrial Entrepreneurs Memorandum) No. 557/SIA/IMO/2005 dated 14.07.2023. It has been issued based on our letter No.IEM/A/AMD/ACK/275773/2023 Dated 16.02.2023 by enhancing the capacity from 16 lacs tonne per Annum to 18 lacs tonne per Annum. In fact, the total capacity pertains to entire Jharsuguda location where Two Smelter units are located out which the SEZ Smelter Unit's capacity is enhanced from 11 lacs to 12.50 lacs tonnes per Annum.

In this regard it is submitted that the Hot Metal i.e primary material the capacity of which has enhanced from 11 LTPA to 12.50 LTPA (Lacs Ton per Annum). In fact the final products like Ingot, Billet etc. is manufactured only after casting of such Hot Metal through casting process.

Therefore, the quantum of composition of such final products may change depending upon the requirement within the capacity limit of 12.50 LTPA.

The Anode production also will get enhanced due to enhancement of capacity of Hot Metal as Anode is required during the electrolysis process of Hot Metal.

As regards the other details like additional investment, Employment and revised Fores, Unit has intimated that, same same have already been factored while submitting the information at the time of renewal of LQA for next five years from 01.12.2020 to 30.11.2025.

Hence, the matter is placed in UAC for discussion and decision.
