The request for renewal of LOA No. SEZ/LIC/T-2/2007/1288 dated 19.06.2007 for IT/ITES beyond 01.05.2023 in respect of M/s. Tata Consultancy Services Limited (Unit-I) at IDCO-I SEZ, Bhubaneswar-751024, Odisha, was discussed and examined in detail by the Committee. Mr. Rajesh K. Nair & Mr. Sushant Kumar Rakesh represented on behalf of the unit during the course of discussion in the UAC and requested their proposal for consideration. The Committee noted that the APR of the unit has been monitored up to 2021-22 and has achieved (+NFE). The Unit also stated that they are expecting a FOB value of Exports of Rs. 82170.00 (Rs. in lakh) for next five years. The Committee also noted that the employment generation should be 1152 Nos in next five years. The request for renewal of LOA No. SEZ/LOA/Unit-II(IDCO)/1/2012/2665 dated 17.10.2012 for IT/ITES beyond 01.05.2023 in respect of M/s. Tata Consultancy Services Limited (Unit-II) at IDCO-I SEZ, Bhubaneswar-751024, Odisha, was discussed and examined in detail by the Committee. Mr. Rajesh K. Nair & Mr. Sushant Kumar Rakesh represented on behalf of the unit during the course of discussion in the UAC and requested their proposal for consideration. The Committee noted that the APR of the unit has been monitored up to 2021-22 and has achieved (+NFE). The Unit also stated that they are expecting a FOB value of Exports of Rs. 759687.00(Rs. in lakh) for next five years. The Committee also noted that the employment generation should be 54554 Nos in next five years. After due deliberation, the committee decided to renew the LoA No. SEZ/LOA/Unit-II(IDCO)/1/2012/2665 dated 17.10.2012, beyond 30.04.2023 w.e.f. 01.05.2023 to 30.04.2028 for another period of 05 (five) years as applied by the unit subject to condition of strict compliance of SEZ Rules & Act, 2005 and other relevant Acts & Rules.

This is regarding non-submission of APRs for the FY 2020-21 and 2021-22 by the Units of M/s Tata Steel SEZ, Gopalpur. The Committee observed that both the units have not submitted APR for the FY 2020-21 as well as 2021-22 for which it is extremely difficult to monitor all these units by this office. Mr. Rashmi Ranjan Behera was present on behalf of M/s East Coast Overseas Pvt Ltd during the course of discussion in the UAC and stated that the APRs will be submitted by today, in reply Committee advised to submit the APRs for the FY 2022-23 with in time limit. No representative was present on behalf of M/s Odimet Resources Pvt Ltd. The Committee advised to issue a letter to the Unit for submission of APR for the FY 2020-21 as well as 2021-22 immediately, and in the event of non-submission of APRs, action will be initiated as per Rules.
