The committee Noted the APR and found 1st year of 2nd block of operation achieved +ve NFE. Committee also directed to increase the export performance as well as employment generation.

Agenda Item No. 139/54.3: Common issues related to SEZ developers / Co-Developers in IDCO- I&II.

A. IDCO-I:

- 1) Installation of Electronically Access Control Systems at Exit and Entry Gate,
- 2) Posting of proper security personnel,
- 3) Raising the height of Boundary wall, in IDCO-I, Infocity, Chandaka.
Estimate is put up for approval.
- 4) Issue of ID Cards for visitors and other matters.
- 5) Renovation of Gate office for custom officers not yet completed.
Sofa replaced with New one and Windows completely changed. Electrical wiring has also changed. Rest has to be completed at the earliest.

B. IDCO-II:

- i. Posting of Police and FIRE Officers and staff at IDCO-II Info Valley for maintenance of Law and Order.
- ii. **Public Transport:** At the Info valley SEZ site, there is no public transport Facility available from main city to SEZ campus. BMC may be requested for the same Welfare facilities like shopping Mall, night club, hotels and housing for the employees may be facilitated.
- iii. **Sole anchor tenant:** Infosys is still the sole anchor tenant, they are in the info valley since its operation of the SEZ in September, 2014 and growth of Infosys constrained due to non-development of eco system which is essential to furtherance of the Zone.

IDCO will take up the matter with the Concerned Ministry/Department Govt. of Odisha for early implementations. Industries Department, Govt. Of Odisha is also requested to take up the matter with the concerned departments by conducting Seminar/Workshops/Road Shows to attract investors. FSEZ has also requested Industry Department for the same. Govt of Odisha may take necessary initiatives to setting up new SEZs in Odisha by holding webinar in consultation with the concerned Departments Govt of India.

Agenda Item No. 139/54.4: Proposal for providing Land of IDCO-II (Info valley) on lease rent basis:

Most of the Industries who want to set up Industries in SEZ are not interested to invest much in Land. In Falta SEZ, Govt is providing land on lease rent basis for a period of minimum 5years and it can be further extended. Similarly this model can be applied for a portion of the vacant land on lease rent basis for in IDCO-II to attract Industries.

IDCO to take necessary initiatives in consultation with the concerned Departments of Govt. of Odisha to attract MSMEs and other Industries.

A) Additional points raised By M/s Infosys:

a) All the street lights from NH to Infosys Campus at Infovalley SEZ are not working properly from last 3 months. After discussed in last UAC meeting IDCO has repaired some. Still more than 50% are not working. As you know that we are the only one Co. in Infovalley SEZ and there are no more small or large industries or units operate so the full length of road from NH to our campus becomes dark due to non-functioning of the all the street light. As our team works 24X7 shift operation so this may lead to safety issues for our staffs working in evening and night shift.

b) we are operating at Infovalley zone from Sep 2014 and in last 6 years we are facing accumulation of rainwater inside our campus. This issue is mainly due to the following reasons:

1. Non availability of storm water drainage system on either side of the main road (from NH to Infovalley)
2. Road level is higher than our campus internal road and drains
3. Non availability of road and drainage system all around our campus.

Whenever there is heavy and continuous rain fall, we face challenges in dewatering the water from our campus to outside and this affects our services. Water from main road flows towards our campus and rain water inside the campus accumulate on the south west corner of our campus for a longer period of time.

We have requested IDCO to share us the locations/drawing plan where we can discharge our storm water so that we can start our construction/ planning accordingly and also provides proper storm water drain facilities at Infovalley.

The UAC directed IDCO Authorities to resolve the issue as soon as possible in a time bound manner.

A. IDCO-I:

- 1) Installation of Electronically Access Control Systems at Exit and Entry Gate,
- 2) Posting of proper security personnel,
- 3) Raising the height of Boundary wall, in IDCO-I, Infocity, Chandaka.
- 4) Issue of ID Cards for visitors and other matters.
- 5) Renovation of Gate office for custom officers not yet completed.

B. IDCO-II:

- i. Posting of Police and FIRE Officers and staff at IDCO-II Info Valley for maintenance of Law and Order.
- ii. **Public Transport:** At the Info valley SEZ site, there is no public transport Facility available from main city to SEZ campus. BMC may be requested for the same Welfare facilities like shopping Mall, night club, hotels and housing for the employees may be facilitated.

- iii. Sole anchor tenant:** Infosys is still the sole anchor tenant, they are in the info valley since its operation of the SEZ in September, 2014 and growth of Infosys constrained due to non-development of eco system which is essential to furtherance of the Zone.

IDCO will take up the matter with the Concerned Ministry/Department Govt. of Odisha for early implementations. Industries Department, Govt. Of Odisha is also requested to take up the matter with the concerned departments by conducting Seminar/Workshops/Road Shows to attract investors. FSEZ has also requested Industry Department for the same. Govt of Odisha may take necessary initiatives to setting up new SEZs in Odisha.
