V., Netherlands (JKG) and according to the agreement between us, JKG was supposed to finish the plates (Embossed plated) and sell it to PPI-JKG in Philippines (Its sister Company of JKG). PPI-JKG turn used to supply it to The Govt. of Philippines.

Business was smooth and we were supplying plates and were regularly paid by our buyer JKG until June 2015, when JKG stopped paying us due to technical reason, the end user (Govt. of Philippines) had stopped paying to his Sister Company in Philippines (PPI-JKG).

But we strongly protested their reason for non-payment and after that they are agreed to pay us in installments.

In this connection we stop supply (Export) the finished materials to Philippines (PPI-JKG) form the 2016-2017 & 2017-2018.

Please also note that now we have realized all dues from our buyer and the problem with the Philippines Govt. has also been sorted.

Hence, we have again started supplying them.
