The Letter of Permission was issued on 13.05.2019 to M/s. Jagmata Vincom LLP, having its registered office at 28, Strand Road, 1st floor, Room No.110, Kolkata-1, for the establishment of a unit at Falta SEZ, Falta for warehousing for fabric garments etc, which was considered by the UAC in its Meeting held 08.05.2019 and subsequently included the additional items viz. Machinery parts, shoes and its accessories, luggage, back packs except Lubricants Oil vide this office letter dated 23.07.2019.

In the meantime, with reference to the guidelines for clearance of unclaimed and abandoned goods kept in SEZs/FTWZs vide Instruction No. 96 dated 31st July, 2019, issued by the DOC, New Delhi vide letter No.D.6/5/2017-SEZ(Vol.II) dated 31.07.2019 the matter was placed before the 115th UAC in its Meeting held on 13.08.2019 to review the Letter of Permission based on the above guidelines. After due deliberation, the committee decided for appropriate guideline since Falta SEZ is a Multiproduct SEZ without any demarcation of FTWZ in terms of Rule 11 of SEZ Rules, 2006 & 53 A(N). Accordingly the committee decided to cancel the LOP and to be examined and kept in UAC subsequent to the clarification received from the DOC, New Delhi.

With reference to the correspondence vide this office letter dated 14/26.08.2018 seeking clarification as to whether the proposal for setting up of the FTWZ units in FSEZ may be allowed or not in terms of provisions of SEZ Act & Rules, this office has received a clarification from the DOC, New Delhi vide their letter NO.K-43014(16)/19/2019-SEZ dated 3rd October, 2019 on the above issue, stating that setting up of the units in SEZs are in purview of Unit Approval Committee(UAC). It was also advised by the DOC, New Delhi that the matter may be placed before the UAC and suitable decision may be taken after examining the same in

accordance with SEZ Act & SEZ Rules. According to the instruction the matter was placed before the 119th UAC for taken suitable decision.

The matter was discussed at length with the presence of all the committee members. But the Committee was not in a position to arrive a unanimous decision since the provision in Rule 53(n) i.e. supply of goods to DTA against payment in foreign exchange from the EEPC A/c. of the DTA buyer or Free Foreign Exchange received from overseas has been withdrawn by Amendment of SEZ Rules, 2019 [2nd SEZ Amendment Rules, 2019). Although in terms of 3rd proviso of Rule 18(5) of SEZ Rules, 2006 stated that PROVIDED also that all transactions by a Unit in Free Trade and Warehousing zone shall only be convertible foreign currency.

Therefore, after due deliberations, the Committee decided to refer the case to BOA for suitable decision.

M/s. Precision Processors (India) Pvt Ltd a SEZ Unit located at FSEZ, holding LOP No. FEPZ/LIC/A-22/1996/4445 dated 15.01.1997 engaged for manufacture and export of Writing/Printing Paper, Base Paper, Tissue Paper cut Paper, (i)Processing/conversion of all kinds of paper into rolls/sheets.(ii) Processing cutting & sizing of paper board (iii) Printing (iv)Paper containers, packing materials (v)Note Books/Pads, Exercise Books. (vi)Paper files.

(2) A Show Cause Notice was issued vide this office letter dated 29.03.2019 as per decision taken by UAC in its 111^{th} meeting held on 27.02.2019 due to non-achievement of (+) NFE for the 4^{th} Block of 5 years i.e. for the FY 2012-13 to 2016-17.

Now, M/s. Precision Processors (India) Pvt. Ltd have submitted a reply vide their letter dated 05.08.2019. Details are as follows:-

(i) Their company was established in way back in 1997 and this has been operating in Falta SEZ for more than 20 years.

- (ii) Their company was doing reasonably well but for sudden dominance of Chinese Paper Products as well as major glut in the paper market, the demands for the products suddenly diminished.
- (iii) Though they tried their level be to make a comeback but could not sustain their selves and which led to negative NFE.

- (iv) In between they have also thought for de-bonding themselves from the SEZ but due to the fact that unit was deploying a few workers for which they thought of continuing with the operation of the unit.
- (v) In any case, they would like to take a decision in the next 06 months whether they will continue to operate the unit or debond/Exit from SEZ.
- (vi) Finally, they have stated that so far as the current position is concerned, they have a few orders which they want to execute and would preferably request to the Development Commissioner to kindly extend the LOP till 31st March, 2020 within which either they will try their best and attain a positinve NFE or otherwise will go for de-bonding of their unit.

- (3) A Show Cause Notice was issued vide this office letter dated 29.03.2019 with a request to explain as to why penalty should not be imposed and LOP should not be cancelled for violation under Section 9(4) and 11(4) of Foreign Trade (Development & Regulations) Act,1992, and for violation of provisions in terms of Section 16(1) of currently enacted SEZ Act,2005 & Rule 54 SEZ Rules, 2006 by occupying space in SEZ without achieving positive NFE.
- (4) According to their request letter dated 05.08.2019, the matter was placed before the 116th UAC meeting held on 090.09.2019. After deliberation, the UAC in its 116th meeting held on 09.09.2019 had decided to consider the extension of your LOP dated 15.01.1997 for a period of six(06) months beyond 30.06.2019 for processing of your Bill of Entry to clear the goods, as deliberated before the UAC by Mr. Gaggar who was represented on behalf of the aforesaid unit and will impose penalties as applicable, in terms of FT(D&R) Acat,1992.
