Minutes of 152nd meeting (11th meeting of the 2022 Series) of the Unit Approval Committee constituted in terms of Section 13 of Sub Section 1 of the Special Economic Zone Act, 2005 held on 30.11.2022 at 1.00 P.M. in the chamber of Development Commissioner, Falta Special Economic Zone, 4th floor, 2nd MSO Building, Nizam Palace, 234/4, AJC Bose Road, Kolkata-700020 through Video Conferencing regarding Falta SEZ, Manikanchan SEZ, Candor Kolkata One Hi-tech Structures Ltd. IT/ITES SEZ, Wipro Ltd. IT/ ITES SEZ and DLF Ltd. IT/ITES SEZs. List of participants is enclosed at Annexure-I.

Shri Satish Kumar, Chairman & CEO welcomed all the members present in the meeting and requested Shri Lakshmi Kanta Halder, Dy. Development Commissioner, Falta SEZ to place the agenda before the Committee for discussion.

Item wise decisions taken were as under:

Agenda Item No. A&B: Ratification of the minutes of 151th UAC meeting held on 31.10.2022.

Minutes of the 151th UAC were circulated to all the members of UAC. As no comments were received, the committee ratified the minutes and confirmed the same.

Agenda Item No.1: Request for inclusion of additional items viz. "Powder Carbon, Treated Carbon, Oxidized Carbon & Black Master Batch" in the existing LOP No. FSEZ/LIC/H-16/2009/372 dated 21.04.2009 of M/s. Himadri Speciality Chemicals Ltd., Falta SEZ, Falta in addition to the existing items of manufacture and export.

The proposal is for inclusion of additional items viz. "Powder Carbon, Treated Carbon, Oxidized Carbon & Black Master Batch" in the existing LOP dated 21.04.2009 of M/s. Himadri Specialty Chemicals Ltd., Falta SEZ, Falta in addition to the existing items of manufacture and export was discussed and thoroughly examined by the committee. Dr. Soumen Chakraborty, partner of the company appeared before the UAC through video conferencing and explained their proposal for consideration. On being asked by the Committee, regarding the DTA unit and stated that they have DTA unit in another place and also clarified that additional items to be included in LOP would be different from the existing items.

After due deliberation, the Committee, decided to approve the inclusion of additional items viz. "Powder Carbon, Treated Carbon, Oxidized Carbon & Black Master Batch" in their existing LOA No. FSEZ/LIC/H-16/2009/372 dated 21.04.2009 in addition to the existing items of manufacture in terms of provision of Rule 19(2) of SEZ Rules, 2006.

The request for Service Tax Exemption on Default Authorized Services, by M/s. Patton International (unit-II) having LOP NO FSEZ/LIC/P-44/2021/1432 dated 31.08.2022 was examined by the Committee. Sri Sumit Goyal represented on behalf of the unit through video conferencing and explained their proposal for consideration.

The Committee, after deliberations, approved the request of M/s. Patton International (Unit-II) for inclusion of services SL No. 1 to SL No. 25 which is covered under 67 default authorized service as per Instruction No. 94 dated 08.05.2019 issued by the Ministry of Commerce and Industry, subject to verification by Customs of the Units submitted invoices bearing necessary details including 03 mandatory details i.e, proper description of services provided with the amount charged for the services, GSTIN of the service provider, LUT execution details of the service provider.

Agenda Item No.3: Request for Service Tax Exemption on Default Authorized Services, by M/s. Patton International (Unit-I), holding LOP No. FSEZ/LIC/P-28/2003/1314 dated 22.05.2003 - regarding.

The request for Service Tax Exemption on Default Authorized Services, by M/s. Patton International (Unit-I) having LOP NO FSEZ/LIC/P-28/2003/1314 dated 22.05.2003 was examined by the Committee. Sri Sumit Goyal represented on behalf of the unit through video conferencing and explained their proposal for consideration.

The Committee, after deliberations, approved the request of M/s. Patton International (unit-I) for inclusion of services as SL No. 1 to SL No. 25 which is covered under 67 default authorized services for their SEZ unit –II as per Instruction No. 94 dated 08.05.2019 issued by the Ministry of Commerce and Industry, subject to verification by Customs of the Units submitted invoices bearing necessary details including 03 mandatory details i.e, proper description of services provided with the amount charged for the services, GSTIN of the service provider, LUT execution details of the service provider.

Agenda Item No.4: Request of M/s. Ostern Pvt. Ltd., for renewal of LOP No. FSEZ/LIC/O-8/2012/150 dated 09.04.2012, for completion of de-bonding purpose - regarding

The request of M/s. Ostern Pvt. Ltd., for renewal of LOP No. FSEZ/LIC/O-8/2012/150 dated 09.04.2012, for completion of de-bonding purpose was discussed and thoroughly examined by the Committee in detail. Shri Ranjan Agarwal represented on behalf of company physically and requested for consideration of their proposal. During the time of discussion the Committee noted that the matter was discussed in 124th UAC meeting held on 18.11.2020 as well as 134th UAC in which LOA extended up to 16.05.2022 exclusively for de-bonding purpose. The Committee further noted that an appeal is lying before the Commissioner

of Customs (Appeal) Customs House, Kolkata. At this moment the unit wants small space of area to continue in SEZ for conclusion of their Appeal.

After due deliberation, the Committee decided to approve for renewal of LOA No. FSEZ/LIC/O-8/2012/150 dated 09.04.2012 absolutely for de-bonding of M/s. Ostern Pvt. Ltd from Falta SEZ, in terms of Rule 19(6A)(3), 2006 till the matter is disposed by the Appellate Authority. The unit will submit a fresh B-LUT after the renewal of LOP is issued

Agenda Item No.5: Request for approval of List of Services for authorized operation at Falta SEZ by M/s. Carbide Cutting Tools Pvt. Ltd. vide their letter dated 16.06.2022, 05.07.2022 and 23.07.2022 – regarding.

The proposal for approval of List of Services for authorized operation at Falta SEZ by M/s. Carbide Cutting Tools Pvt. Ltd holding LOA No. FEPZ/LIC/C-12/97/4242 dated 09.01.1997 was discussed and examined in detail.

The Committee observed that this matter was placed in 146th UAC Meeting held on 27.06.202 and were asked to submit details justification for each of the default list of services required by the their unit. The matter was examine and checked by Falta Customs Wing.

The Committee, after deliberations, approved the request of M/s. Carbide Cutting Tools Pvt. Ltd. for approval of default list of services as Sl No. 6,8,9,11,14,17,19,25,26,28,30,32,33,42,50,54,55,56,59,60,64 and 66 which is cover under 67 services for their SEZ unit as per Instruction No. 94 dated 08.05.2019 issued by the Ministry of Commerce and Industry, subject to verification by Customs of the Units submitted invoices bearing necessary details including 03 mandatory details i.e, proper description of services provided with the amount charged for the services, GSTIN of the service provider, LUT execution details of the service provider.

Agenda Item No.6: Extension of LOA of M/s. Indi Rise Enterprise LLP for further two year w.e.f. 16/05/2022.

The Proposal for extension of LOA of M/s. Indi Rise Enterprise LLP having LOA NO FSEZ/LIC/I-32/2021/225 dated 17/05/2021 for further two year, an unit in Falta SEZ, was discussed in detail and thoroughly examined by the committee. Shri Gourachandra Dash appeared before the committee through video conferencing and requested for consideration of their proposal. The Committee enquired about their date of commencement of trading activity and the unit clarified that due to some internal problem they could not start in time. Now they have orders in hand and they are ready to start their trading activity. Furthermore, the committee directed to the unit that only Monolithics would be allowed for trading and no other restricted items would not be allowed for trading activity.

After deliberation, the committee decided to renew the LoA No. FSEZ/LIC/I-32/2021/225 dated 17/05/2021 w.e.f. 17.05.2022 to 16.05.2023 i.e.for another one year beyond the expiry of their LoA as applied by the unit subject to condition of strict compliance of

SEZ Rules & Act, 2005. In this one year, they are requested to construct their shed immediately and start their Trading process.

Agenda Item No.7: Cancellation of LOP issued to M/s. Modern International, a unit in Manikanchan SEZ, which is non-functional for a long period of time.

The cancellation of letter of Approval issued to M/s. Modern International, a unit in Manikanchan SEZ was discussed and examined in detail by the Committee. Shri Manish Kumar Upadhyay & others on behalf of the concerned unit appeared before the Committee and briefed in detail about the non-functional status of their unit since long. The Committee noted that the unit has no manufacturing activity for which Personal Hearing was given to the concerned unit for want detail discussion. However, they did not appear.

After due deliberation, the committee decided to accord the Director/Representative of the company one last opportunity for Personal Hearing before DC, FSEZ. Thereafter decision for cancellation of Letter of Approval (LOA) will be taken by the DC, FSEZ as per BOA directions.

Agenda Item No.8: Cancellation of LOP of M/s Rohit Export Jewellery LLP, an unit in Manikanchan SEZ – reg.

The cancellation of letter of Approval issued to M/s. Rohit Export Jewellery, LLP a unit in Manikanchan SEZ was discussed and examined in detail by the Committee. Nobody on behalf of the company appeared before the Committee. The Committee noted that the unit has no manufacturing activity as well as Annual Performance Report for the year 2015-16 & 2016-17 has not submitted within the prescribed period. . The Committee further noted that the matter was discussed in its 126th UAC Meeting and decided to issue a SCN. But till date no reply has not been received as yet. Personal Hearing was also given to the concerned unit. However, they did not appear. WBIDC, Developer was also issued SCN dated 28.08.2020.

After deliberation, the committee decided to accord the Director/Representative of the company one last opportunity for Personal Hearing before DC, FSEZ again. Thereafter decision for cancellation of Letter of Approval (LOA) will be taken by DC, FSEZ as per BOA directions.

Agenda Item No.9: Request for approval of “ONE KIOSK” services in the SEZ under provision of Rule 11(5) of SEZ Rules, 2006 at M/s. DLF IT/ITES SEZ, New Town, Rajarhat, Kolkata – regarding.

The proposal for approval of “ONE KIOSK” services in the SEZ under provision of Rule 11(5) of SEZ Rules, 2006 at M/s. DLF IT/ITES SEZ, New Town, Rajarhat, Kolkata was discussed and thoroughly examined in detail by the Committee. Shri Dipak Das, Developer represented through Video Conferencing during the course of discussion in the UAC and requested their proposal for consideration of the same. The Committee noted that the necessary

DLF IT/ITES SEZ, New Town, Rajarhat, Kolkata as requested by the unit subject to condition that no duty exemption will be given and strictly adhered to compliance of SEZ Rules & Act, 2005.

Agenda Item No.10: Request of M/s. Cognizant Technology Solutions India Pvt. Ltd. for renewal of LOA No. SEZ/LIC/C-12/ (UNITECH)/2012/2094 dated 03.09.2012 for next 5(five) years beyond 08.11.2022 -regarding

The request for renewal of M/s. Cognizant Technology Solutions India Pvt. Ltd. for renewal of LOA No. SEZ/LIC/C-12/ (UNITECH)/2012/2094 dated 03.09.2012 for next 5(five) years beyond 08.11.2022 was discussed and examined in detail by the Committee. Shri Parthasarathi K on behalf of the unit appeared through Video Conferencing during the course of discussion in the UAC and requested their proposal for consideration. The Committee noted that the unit has been monitored from 2020-21 to 2021-22 and has achieved (+NFE) and no realization is pending. The Unit also stated that they are expecting a FOB value of Exports of Rs.220755.(Rs. In lakh) in next five years and employment will also enhance.

After deliberation, the committee decided to renew the LoA No. SEZ/LIC/C-12/ (UNITECH)/2012/2094 dated 03.09.2012 w.e.f. 09.11.2022 to 08.11.2027 i.e. for another five year beyond the expiry of their LoA as applied by the unit subject to condition of strict compliance of SEZ Rules & Act, 2005.

After deliberation, the committee decided to approve the cancellation of permission for setting up a Customer Care Centre by M/s Bharati Airtel Ltd at Candor Kolkata One Hi-Tech Structures Pvt. Ltd SEZ as applied for.
