Subject: Minutes of 156th meeting (2nd Meeting of the 2023 Series) of the Unit Approval Committee, Falta SEZ held on 17.02.2023- regarding

Minutes of 156th meeting (2nd Meeting of the 2023 Series) of the Unit Approval Committee constituted in terms of Section 13 of Sub Section 1 of the Special Economic Zone Act, 2005 held on 17.02.2023 at 01.00 P.M. in the chamber of Development Commissioner, Falta Special Economic Zone, 4th floor, 2nd MSO Building, Nizam Palace, 234/4, AJC Bose Road, Kolkata-700020 through Video Conferencing regarding Falta SEZ, Manikanchan SEZ, Candor Kolkata One Hi-tech Structures Ltd. IT/ITES SEZ, Wipro Ltd. IT/ ITES SEZ, Kolkata IT Park SEZ and DLF Ltd. IT/ITES SEZs. List of participants is enclosed at Annexure-I.

2. Shri Satish Kumar, Zonal Development Commissioner, Falta SEZ welcomed all the Members present in the meeting and requested Shri Abhishek Sanyal, Dy. Development Commissioner and Head of Office, Falta SEZ to place the agenda before the Committee for discussion.

3. **Item wise discussed and decisions taken were as under:**

Agenda Item No. A&B: Ratification of the minutes of 154th UAC meeting held on 25.01.2023.

Minutes of the 154th UAC meeting was circulated to all the members of UAC. As no comments were received, the committee ratified the minutes and confirmed the same.

Agenda Item No.1: Request for Permission for re-export of raw materials to their international custodian in Kandla FTWZ by M/s. Esscom Trade INC, a manufacturing unit in Falta SEZ-regarding.

The request of M/s Esscom Trade INC for allowing them to re-export their imported raw material (food items) from Falta SEZ to their international custodian in Kandla FTWZ M/s LMP Overseas, was discussed and examined in detail by the Committee. Mr. Jay Gupta, represented on behalf of the unit in the UAC and requested UAC to consider their proposal. **The Committee after deliberations agreed for Inter SEZ transfer of the raw materials, from Falta SEZ to Kandla FTWZ, in terms of rule 38 of SEZ Rules 2006 subject to the following:**

- i. Consent of M/s LMP Overseas to be taken before movement of the goods.
- ii. LOA details, KYC and credentials of M/s LMP Overseas to be taken from Kandla FTWZ before movement of the goods.
- iii. Bill of Entry shall be filed online by M/s LMP Overseas for transfer of the goods from Falta SEZ to Kandla FTWZ.
- iv. While allowing movement of the goods out of Falta SEZ, a percentage examination shall be conducted by Customs at Falta SEZ, establishing identity of the goods w.r.t. the Bill of Entry Nos. 1) 1001065 dated 11.06.2022 (RID – 172201774404) and 2) 1001066 dtd 11.06.2022 (RID – 172201774964) under which the goods were imported

- into Falta SEZ, and the examination report shall be entered online against the Kandla FTWZ Bill of Entry filed for SEZ to SEZ transfer.
- v. Goods shall be moved under end to end Customs escort (i.e., from Falta SEZ to the Unit in Kandla FTWZ), for which the Falta SEZ Unit M/s Esscom Trade INC will have to obtain services of the escort officer(s) on booking from the Custom House, Kolkata.
 - vi. The Falta SEZ Unit M/s Esscom Trade INC shall produce re-warehousing certificate or online certification of receipt of the goods by the FTWZ Unit M/s LMP Overseas at Kandla SEZ along with due certification of the escort officer(s), which shall then be put on record in file at Falta SEZ and re-warehousing shall be completed online.
 - vii. The Falta SEZ Unit M/s Esscom Trade INC furnishes an Undertaking before the Development Commissioner, FSEZ to the effect that they shall pay the entire Duty applicable on the goods along with Fine and Penalty imposed (if any) in case of any mishap in transit, leading to loss or damage of the entire goods or a portion thereof before it reaches the destination at Kandla SEZ.
 - viii. Considering the perishable nature of the goods, Falta SEZ authority will not be responsible for quality deterioration of the goods (if any) happened during storage/transit.

The Goods will be dealt as per the SEZ Rules 2006, Instructions of DOC and Customs Rule 1962.
