Minutes of 120th meeting of the Unit Approval Committee Constituted in terms of Section 13 of Sub Section 1 of the Special Economic Zone Act, 2005 held on 24.02.2020 at 3.00 PM in the Chamber of Development Commissioner, Falta Special Economic Zone 4th floor, 2nd MSO Building, Nizam Palace, 234/4, A.J.C Bose Road, Kolkata-700 020 regarding Falta SEZ, Candor Kolkata and DLF IT/ITES SEZs. List of participants is enclosed at Annexure-I.

Dr. B.K. Panda, Chairman & CEO welcomed all the members present in the meeting and requested to Shri M.K. Anjanaiah, Dy. DC, Falta SEZ to place the agenda before the Committee for discussion.

Item wise decisions taken were as under:

Agenda Item No. 01: Ratification of the minutes of 119th UAC meeting held on 15.01.2019

Minutes of the 119th UAC meeting was circulated to all the members of UAC. As no comments were received, the committee ratified the minutes and confirmed the same.

Agenda Item No.2: Request of Modification of ITC (HS) Code in the LOA by M/s. Delta Plus (India) Pvt. Ltd, a manufacturing cum trading unit in Falta SEZ, holding LOP No. FSEZ/LIC/D-20/2005/7171 dated 07.01.05.

The request for modification of ITC (HS) code in the existing LOA FSEZ/LIC/D-20/2005/7171 dated 7/01/2005 of M/s. Delta Plus (India) Pvt. Ltd., as a manufacturing cum trading unit of Falta SEZ was discussed at length. Mrs. Dhara Agarwal, an Authorized representative of the unit appeared before the committee and explained their request for consideration of their proposal.

The Committee noted that the ITC(HS) Code No.62113300 is not matching with the trading items i.e. Man-made Fibers based on DGFT ITC(HS) Classification.

After due deliberation, the committee decided that the unit may be requested to clarify the category of items and to submit a revised/correct ITC (HS) Code for such inclusion so that case is deferred and the matter may be taken up in the next UAC Meeting.

Agenda Item No.3: Request for renewal of Letter of Approval of M/s. Best Safety Pvt. Ltd., a manufacturing unit of Falta SEZ, Falta as per 19(6A)(1) of SEZ Rules, 2006.

The request for renewal of Letter of Approval of M/s. Best Safety Pvt. Ltd, a manufacturing unit of Falta SEZ was discussed. No one appeared before the committee on behalf of the said unit.

The Committee has noted that the last extension of LOP was considered for a period of one year w.e.f. 28/4/2019 to 27/4/2020 as communicated vide this office letter dated 1/5/2019.

After due deliberation, the committee decided to approve for renewal of the LOP for the balance period of four years beyond 27/04/2020 i.e. w.e.f. 28/4/2020 to 27/4/2024 based on submission of F1, in terms of provision in Rule 19(6A)(1) of SEZ Rules, 2006.

Agenda Item No.4: Request for inclusion of items of manufacturing and selling against LOP No. FSEZ/LIC/P-31/2005/729 dated 06.05.2005 of M/s. Pasari Silk Industries Ltd, a unit at Falta SEZ.

The request for inclusion of additional items of Manufacturing viz. Processed Pile Velvet Fabric Made with 56% Viscose and 44% Cotton 355 GST + 5% with annual capacity of 30,000 Meters against ITC HS Code No.58013690 for export in the existing LOP No. FSEZ/LIC/P-31/2005/729 dated 06.05.2005 was discussed. No one appeared before the committee. The committee noted that necessary approval of the Competent Authority has already been granted, as communicated through ISN dated 7/02/2020 addressed to the Specified Officer, Falta SEZ. After due deliberation, the matter has been ratified by the committee.

Agenda Item No.5: Request for inclusion of additional items ITC(HS) codes 7326 19 90, 7609 00 00, 4016 93 40, 7907 00 90 & 7405 99 00, of M/s. Patton International Limited, holding LOP No. FSEZ/LIC/P-28/2003/1541 dated 29.07.2013.

The request for inclusion of additional items against ITC(HS) Code No.7326 19 90 - Other; under broad heading "other Articles of Iron & Steel" with annual capacity 200 M/T, (2) ITC(HS Code No. 7609 00 00 -Aluminium Tube or Pipe Fittings (e.g.h. Couplings, Elbows, Sleeves) with annual capacity 150 M/T, (3) ITC(HS) Code No. 4016 93 40 - Gasket; under broad heading "Other Articles of Vulcanized Rubber other than Hard Rubber" (4) ITC(HS) Code No.7907 00 90- Other; under broad heading "Other Articles of Zinc" and ITC(HS) Code No. 9405 99 00- Other "under broad heading ' Lamps and Lighting Fittings including searchlights and sport lights and parts thereof not elsewhere specified or included; illuminated signs, illuminated name plates and the like , having a permanently fixed light source and parts thereof not elsewhere specified or included in the existing LOP No. FSEZ/LIC/P-28/2003/1541 dated 29.07.2013 of M/s. Patton International Limited was discussed at length. No one appeared before the committee.



After due deliberations the committee has been approved for inclusion of additional items against ITC(HS) Code No.7326 19 90 - Other; under broad heading "other Articles of Iron & Steel" with annual capacity 200 M/T, (2) ITC(HS) Code No. 7609 00 00 -Aluminium Tube or Pipe Fittings (e.gh. Couplings, Elbows, Sleeves) with annual capacity 150 M/T, (3) ITC(HS) Code No. 4016 93 40 - Gasket; under broad heading "Other Articles of Vulcanized Rubber other than Hard Rubber" (4) ITC(HS) Code No.7907 00 90- Other; under broad heading "Other Articles of Zinc" and ITC(HS) Code No. 9405 99 00- Other "under broad heading ' Lamps and Lighting Fittings including searchlights and sport lights and parts thereof not elsewhere specified or included; illuminated signs, illuminated name plates and the like , having a permanently fixed light source and parts thereof not elsewhere specified or included in the existing LOP No. FSEZ/LIC/P-28/2003/1541 dated 29.07.2013 of M/s. Patton International Limited in terms of SEZ Rules, 2006.

Agenda Item No.6: Request for M/s. Tristar Global Traders Pvt Ltd., a unit in Falta SEZ for renewal/extension of Letter of Permission No.LOA No. FEPZ/LIC/T-11/99/3032 dated 30/06.1999 beyond the expiry of validity of LOP.

The request for M/s. Tristar Global Traders Pvt. Ltd., for renewal /extension of Letter of Permission No. LOA No. FEPZ/LIC/T-11/99/3032 dated 30/06/1999 beyond 13/12/2019 was discussed. The authorized representative of the concerned unit Mr. Binod Garodia and Shri D. Chakraborty appeared before the committee and explained their request for consideration of their proposal for extension of validity of LOA.

During the course of discussion it was observed the following:

1. The status of the unit as a Trading & Warehousing at Falta SEZ, Falta.
2. The request for resumption/revival of operation was considered by the 107th UAC in its Meeting held on 27/11/2018 with certain conditions.
3. Subsequently the authority was also considered for inclusion of additional items viz. Multi Function Printers/Copiers (MFD's), Parts and Components of Photocopiers Machines, Parts & Components of MFD's, Photocopiers Machines & Medical & Pharmaceutical Accessories & Equipments in the existing LOA, as communicated via this office letter dated 26/4/2019 which was duly ratified by the 112th UAC in its Meeting held on 08/5/2019.
4. The Customs authority, FSEZ has pointed out before the committee that there is some discrepancy for release of import consignment for the aforesaid items in the light of Amended Notification No.05/2015-20 dated 7.05.2019 while importing old and used Photocopiers Machine/MFD's etc. Even the DOC, New Delhi has also re-iterated the clarification and also has specifically added that i) why the FSEZ authority is allowing import of prohibited items into SEZ? (ii) Who is buying these items with SEZ area? Since these items are prohibited for import, SEZ unit cannot send these items to DTA.
5. Being aggrieved the decision of Customs Authority regarding release of import consignment, the said Unit has also filed a Writ Petition No.23347/2019 before the Hon'ble High Court at Calcutta and it is sub-judice.



After due deliberation the committee decided to approve the renewal of validity of LOA No. FEPZ/LIC/T-11/99/3032 dated 30.06.1999, (which was already considered for revival/resumption of operation for a period of one year effective from 14/12/2018), for a further period of one year beyond the expiry of LOP i.e. from 14/12/2019 to 13/12/2020 to continue the export-import activity as a SEZ unit except the sub-judice items.

Agenda Item No.7: Request for renewal/extension of M/s. Subhadra Traders Pvt. Ltd for their LOA No. FSEZ/LIC/S-96/2006/3872 dated 12.10.2006 beyond the expiry of validity of Letter of Approval.

The request for M/s. Subhadra Traders Pvt. Ltd., as a manufacturing unit for renewal /extension of Letter of Permission No. LOA No. FSEZ/LIC/S-96/2006/3872 dated 12/10/2006 was discussed at length. The authorized representative of the concerned unit Mr. Binod Garodia and Shri D. Charaboty appeared before the committee and explained their request for consideration of their proposal for extension of validity of LOA.

After due deliberation the committee decided to defer the matter for the next UAC since the matter is sub-judice as the unit holder has filed a Writ Petition before the Hon'ble High Court at Calcutta bearing Writ Petition No.23320/2019.

Agenda Item No.8: Request for renewal of LOP beyond 31.12.2019 vide letter dated 13.01.2020 for a period of three months up to 31.03.2020 of M/s. Precision Processors (India) Pvt. Ltd holding LOP No. FEPZ/LIC/A-22/1996/4445 dated 15.01.1997.

The request for renewal of LOP No. FEPZ/LIC/A-22/1996/4445 dated 15.01.1997 beyond 31.12.2019 M/s Precision Processors (India) Pvt. Ltd have discussed. Mr Prabin Bihari, the authorized representative of the concerned unit appeared before the committee and explained their request for consideration of their proposal.

The request of M/s. Precision Processors (India) Pvt. Limited vide their letter dated 13.01.2020 for renewal of LOP beyond 31.12.2019, for a period of three months i.e. upto 31.03.2020, as they have a few orders which they want to execute, within which either they will try to achieve a positive NFE or otherwise will go for de-bonding of their unit was discussed at length. The representative of the unit was appeared before the committee and requested to consider for renewal of LOP upto 30th June, 2020.



During the course of discussion it was observed that a Show Cause Notice dated 29th March, 2019, was issued in their favour for negative NFE for the last five years i.e. from 2012-13 to 2016-17 to the tune of Rs. 0.53 Crore, cumulatively. The matter was also placed before the 116th UAC Meeting, held on 09/09/2019 and the committee was decided to impose penalties, as applicable, in terms of FT(D&R) Act, 1992.

After due deliberation the committee decided to consider the renewal of validity of LOP for a further period of six months i.e. upto 30.06.2020 for the purpose of execution of export order subject to submission of a revised letter for considering renewal of validity of LOP upto 30.06.2020 instead of their original request and to make payment of penalties for negative NFE for the FY 2012-13 to 2016-17, as applicable, in exercise of the powers vested under Section 13 of the FT(D&R) Act, 1992 and Section 11 of the said Act for imposition of penalty @ 1% of (-) NFE (Cumulative) to the tune of Rs. 0.53 Crore. It was also decided to issue an Order in-Original for adjudication in terms of FT(D&R) Act, 1992 with imposition of penalty, as applicable in favour of the said unit.


Agenda Item No.9: Inclusion of new items viz. Auto Radiator and Inter Cooler in the existing LOA No. FSEZ/LIC/U-14/2006/3282 dated 31.08.2006 of M/s. United Sales Agency A Trading unit in Falta SEZ.

The request for inclusion of additional items viz. Auto Radiator and Inter Cooler under ITC(HS) Code No.8708.91.00, as a Trading item, in the existing LOA No. FSEZ/LIC/U-14/2006/3282 dated 31.08.2006 of M/s. United Sales Agency as a Trading unit in Falta SEZ was discussed at length. Mr Subir Ghosh Director of the said unit have appeared before the committee and explained their request for consideration of their proposal.

After due deliberation, the committee decided to approve the same for inclusion of additional items viz. Auto Radiator and Inter Cooler under ITC(HS) Code No.8708.91.00, as a Trading item, in the existing LOA No. FSEZ/LIC/U-14/2006/3282 dated 31.08.2006 of M/s. United Sales Agency with same terms and conditions as stipulated in the original LOP in terms of provision in Rule 19(2) of SEZ Rules, 2006.

Agenda Item No.10: Request for endorsement of Supplier' Invoices related to tea, Cofee, water and Snacks Vending machine etc for all TCS SEZ locations at Kolkata.

The Committee, after deliberations, approved the request of M/s. Tata Consultancy Services Ltd IT/ITES for endorsement of Supplier's Invoices related to tea, coffee, water and snacks vending machine etc. for all TCS SEZ located at Kolkata, as applied in terms of provision in Rule 27(2) of SEZ Rules.



Agenda Item No.11: Request for inclusion of additional services in the default authorized list of services of M/s. Tata Consultancy Services Ltd IT/ITES.

The Committee, after deliberations, approved the request of M/s. Tata Consultancy Services IT/ITES SEZ for inclusion of additional services in the default authorized list of services from sl. No.1 to 11, in their units under LOA No. SEZ/IT-ITES/ER/U-12/2008/351, SEZ/IT/ITES/ER/ U14/2010/434, SEZ/LIC/T9 (Unitech)/2011/593, SEZ/LIC/T-10(Unitech/2011/3111, DLF SEZ/LIC/C-1/2011/1367, FSEZ/LIC/T-25/2014/3719 & FSEZ/LIC/T-26/2019/1841 for incorporation for filling application for MEIS/SEIS. in terms of provision in F. No. D.12/19 as requested by them.

Agenda Item No.12: Request for approval of default list of services in terms of Instruction No. 79 dated 19.11.2013 issued by DOC, applied by M/s. ii global, a unit in M/s. Candor Kolkata One Hi-Tech Structures (P) Ltd IT/ITES holding LOA No FSEZ/LIC/I-1/2019/2778 dated 25.11.2019.

The request for approval of default list of services in terms of Instruction No. 79 dated 19.11.2013 by M/s. ii global , a unit located in M/s. Candor Kolkata One Hi-Tech Structures (P) Ltd have discussed. Mr Ramesh Kumar authorized person on behalf of the company have appeared before the committee and explained their request for consideration of their proposal.

After due deliberation, the committee decided to approve the default list of authorized operation from sl. No.1 to 57 and in case of remaining default list of authorized operation from sl. No.58 to 65 may be clarified by the DOC, New Delhi since some ambiguity for the services as the IT/ITES SEZ units has applied as a default list of authorized operation and thereafter it may be placed in the next UAC for further action.

Agenda Item No.13: Request of M/s. Indorama Ventures Global Shared Services Pvt. Ltd for setting up of a new unit at Candor Kolkata One Hi-tech Structures Pvt. Ltd. IT/ITES Rajarhat, Kolkata.

The request of M/s. Indorama Ventures Global Shared Services Pvt. Ltd for setting up of a new unit at Candor Kolkata One Hi-tech Structures Pvt. Ltd IT/ITES Rajarhat, Kolkata was discussed at length. Mr. Ajay Wadhwa and others on behalf of the company appeared before the committee and explained their case for consideration of new application.
