Agenda item no. 189.1: Ratification of the minutes of the 186th meeting of the Unit Approval Committee held on 27th November, 2024.

Minutes of 186th UAC meeting was circulated to all the members of the Committee. As no comments were received from members, the 189th UAC ratified the minutes.

Agenda item no.189.2 (i) : Request for approval of "Default list of Services" for authorized operation at Falta SEZ by M/s. Kkalpana Industries (India) Ltd.

Shri Mukesh Tandon physically represented the unit before the Committee. The unit has requested for approving 5 (five) services as their default services.

It was observed that 180th UAC had <u>in principally</u> approved the said 5 (five) services [among others] as default services i.r.o. the unit. And the UAC had decided to give formal approval only after the unit submits requisite documents to establish that the services are getting availed by them in the SEZ.

And it was further observed that Customs Wing, Falta SEZ vide Inter Section Note dated 04.12.2024 has confirmed, based on supporting documents, that the said services have been procured by the unit at Falta SEZ.
