Minutes of 108<sup>th</sup> meeting of the Unit Approval Committee Constituted in terms of Section 13 of Sub Section 1 of the Special Economic Zone Act, 2005 held on 13.12.2018 at 11.00 AM in the Chamber of Development Commissioner, Falta Special Economic Zone 4<sup>th</sup> floor, 2<sup>nd</sup> MSO Building, Nizam Palace, 234/4, A.J.C Bose Road, Kolkata-700 020 regarding Falta SEZ, Manikanchan SEZ, Wipro, Candor Kolkata, M.L. Dalmiya & Company TCS and DLF IT/ITES SEZs. List of participants is enclosed at Annexure-I.

Shri B.K. Panda, Chairman & CEO welcomed all the members present in the meeting and requested Dr. Sriramappa V, Dy. DC, Falta SEZ to place the agenda before the Committee for discussion.

**Item wise decisions taken were as under:**

**Agenda Item No. 01:** Ratification of the minutes of 107<sup>th</sup> UAC meeting held on 27.11.2018 Minutes of the 107<sup>th</sup> UAC meeting was circulated all the members. As no comments were received, the committee ratified the minutes and confirmed the same.

**Agenda Item No.2:** Application of M/s. Ganesh Steel Impex LLP for setting up a new unit in Falta SEZ, Falta.

M/s. Ganesh Steel Impex LLP for setting up of a new unit under SEZ Scheme for manufacture/Services of Bio Diesel, Base Oil under ITC (HS) Code 38260000 and 27101960 was discussed in detail. The representative of the unit appeared before the committee and explained their case for consideration.

After due deliberation the committee decided to approve their proposal for setting up of new Unit in the premises M/s. Costal Energy Limited in Falta Special Economic Authority Zone. The committee directed the unit to submit an undertaking in the prescribed format as pointed by the Specified Officer assets and Liabilities of the M/s. Costal Energy Limited.

**Agenda No. 3: Request for M/s. Rajesh Auto Merchandise Pvt Ltd for setting up a new unit at Falta SEZ, Falta.**

The committee discussed the request of M/s. Rajesh Auto Merchandise Pvt Ltd, for setting up a new unit at Sector-III beside the Container Handling under the jurisdiction of Development Commissioner, Falta SEZ for manufacture and export of Barges in Jetty area. The representative of the Firm Mr. A. Agarwal appeared before the committee and deliberated their request.

During the course of discussion the committee has noted the following:

The Firm intends to set up a SEZ Unit at Sector-III for manufacture of Barges and to export it to Bangladesh within the space near about 1 Acre.

As per records available with us only Sector I & II is covered as a Notified Customs Bonded area.

Subject to approval of the Commissioner of Customs to notify the additional area located at Sector-III, which is earmarked for Container Handling jetty itself which is required to measure to ascertain the actual area by the Engineering Consultancy Agency and to submit a report to this office.

Fixation of rate of Lease Rent for allotment of open land at Sector-III to be decided by the Competent authority of the Zone.

To justify the rate of rent will be fixed and also New LOA will be issued after taken into account of total revenue which will come on lease for Container Handling Jetty. The process of E-tendering of jetty is under consideration is under progress.

After due deliberation the Committee decided to defer the matter for the next UAC Meeting.

**Agenda No. 4: Request of M/s. Candor Kolkata One Hi-tech Structures Private Limited, Developer for permission on offering alcohol to international guest and during get together events inside the SEZ, Rajarhat, New Town Kolkata.**

The request of M/s. Candor Kolkata One Hi-tech Structures Private Limited, for permission on offering alcohol to international guest and during get together events inside the SEZ, Rajarhat, New Town Kolkata was discussed in detail.

Shri. Chatterjee and Shri S. Ghosh on behalf of M/s. Candor Kolkata One Hi-tech Structures Pvt Ltd appeared before the committee and explained in detail their case for consideration.

After deliberation the Committee approved the proposal subject to condition that they should obtain license from State Excise Department and area should be properly identified in the non processing area of SEZ.

Subject: Proposal for inclusion of additional and related item for import and Export in the existing LOP No. FEPZ/LIC/T-10/99/1511 dated 12.5.1999 as extended upto 27.12.2019 with the same terms and conditions of original LOP.

M/s. Transworld Business Corporation, as a Manufacturing unit located at Falta SEZ, Falta for manufacture and export of Lay Flat Tubes/Garbage Bags/Sheet/Film (LDPE/HDPE/PP/BOPP and subsequently included the additional, items viz. Plastic Granules made out of plastic Agglomerates/Floor Sweeping in the existing LOP, being the same group of items vide this office letter dated 13.4.2004 has submitted a proposal for inclusion of additional and related items for import and its export in the existing LOP No. FEPZ/LIC/T-10/99/1511 dated 12.05.1999, are as follows:

- A. **Item of Import :** Plastic Scrap/Waste/Lump (Virgin Grade) with annual Capacity of 7500 M/T
- B. **Item of Export:** Plastic Granules/Agglomerates

**Request at a glance** : Presently they are importing Plastic Floor Sweep, Granules etc. from European Countries, Middle East Countries and USA. In the last 3-4 years the situation has been changed and the consumption of secondary materials and availability for import in India has become very scares. In view of the situation survival of their unit has become very difficult due to non availability of such materials at competitive price. For survival of their unit they intend to make backward integration in plastic recycling by importing plastic scrap/waste/lumps etc. and then processing the same to make granules for captive consumption. They will also be able to export at least 50/55% of Plastic agglomerates and granules, as a finished product. They



have also produced a copy of projected Balance Sheet for the next five years for such inclusion.

- (a) It may be noted that in **Rule (4A) of SEZ (Amendment) Rules, 2018** for existing plastic or used clothing units in SEZs is as under:
- (i) Broad banding and splitting of licence for setting up of sub units shall not be allowed and all transactions of a Unit shall be regulated through a single Bank account ;
  - (ii) No third party exports shall be allowed by any such Unit;
  - (iii) All such units shall set up facilities to make products out of used clothing or plastic waste;

M/s. One Plus Fashion Pvt. Ltd. & Anr. -VS- UNION OF INDIA & ORS.

The proposal for renewal of LOA dated 24.11.2005 was placed before the 107<sup>th</sup> UAC in its Meeting held on 27/11/2018 and accordingly the committee approved the proposal subject to certain conditions (1) submission of required information in F-1 (2) to clear the rental dues to the tune of Rs.9, 76,103/- in three equal installments [@Rs.3,25,368/- per installment] Import/Export will be closely monitored and letter submitted by the unit should be clarified.

In this context it is noted that the aforesaid unit has submitted the F1, in the prescribed format but it is not in order and accordingly they have requested to submit the corrected F1, furnishing Forex Balance Sheet for the appropriate current Block vide this office letter dated 5/12/2018. Although in response to this office letter, they have submitted the same which is placed in file. Further it is stated that they have cleared the rental dues for Rs. 3,00,000/- , as confirmed by the Estate division, out of total outstanding rental dues to the tune of Rs. 9,76,100/- although the committee was advised to clear the rental dues in three equal monthly installment @ Rs.3,25,368/-.

Further it may also be noted that in the meantime this office has received a communication regarding unauthorized removal of imported materials by M/s. One Plus Fashion Pvt. Limited from the Commissioner of Customs (Airport & Administration), ACC, NSCBI Airport, Kolkata-70 052 vide their letter dated 6/12/2018. Accordingly, an investigation in this regard was initiated and all the four addresses, as mentioned in the



IEC details including the unit of M/s. One Plus Fashion Pvt. Ltd. was searched on 03.12.2018 as communicated by the Customs authority. In the line of investigation they had requested to forward the copy of document and necessary information. This was also complied.

In view of the circumstances the competent authority had decided that 'Let the investigation complete. It may be considered thereafter.

Being aggrieved the decision, M/s. One Plus Fashion Pvt. Ltd. had filed a Writ Petition No. W.P. No.26337(W) of 2018 before the Hon'ble High Court at Kolkata. Accordingly the matter was taken up for hearing before the **Hon'ble Justice Debangsu Basak on January, 03, 2019**, after hearing the submissions of the learned advocate for the parties Hon'ble Justice was, interalia, pleased to direct the respondent No. 7 (DC/FSEZ) to take a decision in accordance with law within a period of seven(7) days from the date of order regarding renewal of LOA granting opportunity for hearing to the petitioners and the Respondent No.7 is also granted liberty to take views of concerned respective departments.

In view of the directives of the Hon'ble Court at Kolkata the Development Commissioner had complied the same and requested to the unit to appear before the Development Commissioner, Falta Special Economic Zone on 7<sup>th</sup> January, 2019 at 2.30 P.M. for reasonable opportunity for a personal hearing to comply the Court Order at the Office of the Development Commissioner, Falta Special Economic Zone, Ministry of Commerce & Industry, Government of India, 2<sup>nd</sup> MSO Building, 4<sup>th</sup> Floor, Nizam Palace, 234/4, AJC Bose Road, Kolkata-700 020 as communicated through mail and vide this office letter F.No. Legal/One Plus Fashion/W/P/ No.26337(W)/2018/5077-5081 dated 4<sup>th</sup> January, 2019. Accordingly Mr. Arijit Chakrabarti, Advocate of Hastings Chambers, 7C, Kiran Sankar Roy Road, Kolkata had appeared before the DC,FSEZ on 7<sup>th</sup> January, 2019 producing a VAKALATNAMA dated 7/1/2019 and discussed the matter at length. He has also advised to submit a written submission to this office.

In view of the overall situation, as reflected in the Writ Petition vis-a-vis Court Order dated 3/1/2019 of Hon'ble Justice Debangsu Basak Kolkata High Court, hence the matter is placed before the committee for taking a decision in this regard.
