Agenda Item No. 01: Ratification of the minutes of 115th UAC meeting held on 13.08.2019

Minutes of the 115th UAC meeting was circulated all the members. As no comments were received, the committee ratified the minutes and confirmed the same.

Agenda Item No.2: Regularization of Non-fulfillment of + ve NFE M/s. Modern Solar Pvt. Ltd is holding LOP No. FSEZ/LIC/M-43/2009/541 dated 01.05.2009 for manufacturing and export of Solar Photovolatic Modules & Cells.

The regularization of Non-fulfillment of + ve NFE of M/s. Modern Solar Pvt. Ltd of Falta SEZ for manufacturing and export of Solar Photovolatic Modules & cells have discussed in detail. Mr. J. 
