

An issue was raised on this point as to whether the BoA should be sitting in decision of these minor details in each case. The Member Secretary informed the Board that the amended provisions of SEZ Rules require that in each case the manner of fencing of the demarcated processing area and entrylexit points has to be approved by the BoA. After detailed deliberations it was decided that:

- (i) In case of the IT/ITES/EH/Biotechnology SEZs the BoA's power to decided manner of fencing and number of entry exit points shall be exercised by the Development Commissioner concerned who shall keep the BoA informed of the decisions in this regard.
- (ii) Wherever, the developers are proposing to create 2.4 meters high wall/chain linked fencing with 0.6 meters barbed wire fencing with single entry/exit points, as was provided in the SEZ Rules 2006 prior to amendment dated 16<sup>th</sup> March 2007, no separate approval of the BoA shall be required.
