Agenda Item No. 1: Ratification of the minutes of 33rd FSEZ Authority meeting held on 15.07.2019

Agenda Item No. 2: Approval of Annual Accounts of Falta SEZ Authority for the FY 2018 - 2019

In compliance to Rule 11 of SEZ Authority Rules, 2009 the Annual Accounts of Falta SEZ Authority for the FY 2018 - 2019 has been prepared by the firm of Chartered Accountants M/s. C. S. Patro & Associates, New Delhi.

Agenda Item No. 4: Ratification of works completed by M/s. WAPCOS Ltd.

The below mentioned Construction/Repair/Renovation works at Falta SEZ have been completed by M/s. WAPCOS Ltd. and the details are as follow:-

Agenda Item No. 5: Matter related to Construction of approach road to proposed Kendriya Vidyalaya

It is proposed to construct approach road to proposed Kendriya Vidyalaya on south side of boundary wall (length – 735 Mtr.) at Falta SEZ. M/s. WAPCOS Ltd. (a Govt. of India Undertaking) has submitted estimates for the same for an amount to the tune of Rs. 1,29,23,096/- (Rupees One Crore Twenty Nine Lakh Twenty Three Thousand Ninety Six only) including WAPCOS Design Consultancy Charges @ 10% and WAPCOS PMC charges @ 10%.

The matter is placed before the committee for consideration.

Agenda Item No. 6: Matter related to Installation of Solar PV Cell on DC Building at Falta SEZ

It is proposed to install Solar PV Cell on DC building at Falta SEZ. M/s. WAPCOS Ltd. (a Govt. of India Undertaking) has submitted estimates for the same for an amount to the tune of Rs. 1,21,73,200/- (Rupees One Crore Twenty One Lakh Seventy Three Thousand Two Hundred only) including WAPCOS Design Consultancy Charges @ 20% and WAPCOS PMC charges @ 10%.

The matter is placed before the committee for consideration.

Agenda Item No. 7: Ratification of deployment of 10 Nos. additional Security guards at FSEZ

It was proposed by the Assistant Security Officers, Falta SEZ for deployment of additional 10 Nos. Security Guards at Falta SEZ due to incidents of theft happening in the units at Falta SEZ on regular basis by the mischievous persons and hence the deployment of 10 Nos. additional Security guards was done on priority basis w.e.f. August 2019.

Accordingly, the agency providing Security services increased the charges from Rs. 13,53,819/- only to Rs. 14,89,999/- only which is 10% increase and the same is permissible under GFR.

Agenda Item No. 8: Engagement of 2 persons on contractual basis

It is proposed to engage 2 persons for providing office support services on contract basis through an outsourcing, agency. The expenditure will be met from the FSEZ Authority Fund.
