Minutes of 36th FSEZ Authority meeting held on 13.01.2021 at 03:30 PM

36th FSEZ Authority Meeting was held on 13.01.2021 at 03:30 PM under the Chairmanship of Dr. B. K. Panda, Development Commissioner & CEO, Falta SEZ Authority. The following Members of the Authority were present:

Besides, during meeting, Shri M. K. Mondal, Sr. Accounts Officer, Shri Ratan Nandan, Secretary Falta SEZ Authority, Shri P. K. Panda, ADC and Shri B. Murmu, ADC were also present to assist the Authority.

At the outset, the Chairman and CEO, Falta SEZ Authority welcomed the participants and after brief introduction, each item included in the agenda were taken up for deliberations one by one.

The Gist of discussions/decisions taken is as under:

1. Ratification of Minutes of 35th FSEZ Authority meeting held on 04.09.2020:

Minutes of the 35th Authority meeting was circulated to all the members. As no reference was received against any of the decisions taken in its meeting of FSEZ Authority held on 04.09.2020. Accordingly, the minutes of the meeting held on 04.09.2020 were ratified.

2. Ratification of works awarded to M/s. WAPCOS Ltd.:

The below mentioned Construction/Repair/Renovation works at Falta SEZ have been awarded to M/s. WAPCOS Ltd. and the details are as follow:-

4. Innovative steps to be taken by Falta SEZ on the eve of 75th year of Indian Independence:

It was proposed to take up some innovative steps on the eve of 75th year of Indian Independence by Falta SEZ Authority. The innovative steps are as follow:-

Decision: The Committee after due deliberations, approved the proposed innovative works.

Table Agenda:

1. Engagement of Consultant:

It was proposed for engagement of two consultants from retired Govt. Officers in the justified exigencies of the official work in public interest.

The committee, after deliberation, decided to approve the proposal initially for a period of 3 months w.e.f. 01.02.2021 subject to the following conditions:

- I. A fixed monthly amount of Rs. 33,000/- only as consolidated amount which is less than the amount arriving at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract.
- II. There will be no annual increment/percentage of increase during the term of the contract period.
- III. They may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement.
- IV. No HRA shall be admissible.
- V. Paid leave of absence may be allowed at the rate of 1.5 day for each completed months of service. Accumulation of leave beyond a calendar year may not be allowed.
- VI. The consultant shall sign an agreement of confidentiality with the Govt. of India and FSEZ Authority containing a clause of Ethics and Integrity.

The Committee, after deliberation, approved the proposal.

2. Solar Fencing:

The Falta SEZ Authority has decided to put up solar fencing over the boundary wall of Falta SEZ for 1 Km length with 6 lines as a pilot project.

The Committee, after deliberation, approved the proposal.

3. Droné:

The Falta SEZ Authority has decided to introduce Drone for security surveillance inside zone.

The Committee, after deliberation, approved the proposal.



 Approval of Financial Statement (Balance Sheet) for the FY 2019-2020 in accordance with Rule 6 (I) (IV) & 12 (II) and Schedule III of SEZ Authority Rules, 2009:

The Financial Statement for the year 2019-20 of FSEZ Authority, prepared by a nominated CA firm viz. M/s. C. S. Patro & Associates was placed before the Authority for approval. As per Office Memorandum No. H-11020/1/2017-SEZ dated 01.11.2017 issued by DOC, it needs to be forwarded to CAG.

Decision: The Committee after deliberations approved the Balance Sheet for the year 2019-20.
