The EMD shall be payable through DD. 4. EMD amount shall be paid through DD in favour of Falta SEZ Authority, Kolkata. The EMD is refundable if the bid is not successful. Payment by any other mode such as Cheques/ Cash will not be accepted for the aforesaid purpose. Bidders, not depositing the earnest money, will not be allowed to participate in the e-Auction.

6. For the purpose of participation in the e-Auction, the intending bidder must have availed Digital Signature Certificate (DSC- Class III & above). Any intending bidder, presently not having DSC may procure it from any Licensed Certifying Authority authorized under Section 24 of the Indian I.T. Act 2000 (CA).
7. The intended bidders should have valid Trade License, GSTIN, Import Export Code (IEC) and the same must be furnished along with EMD.
8. E-auction will be conducted on **06.10.2025 at 11:30 Hrs TO 12:30 Hrs with 10 extension of 5 minutes each.**

9. During the e-auction bidders will be allowed to offer higher bid in inter-se bidding over and above the last bid quoted and the minimum increase in the bid amount to the last higher bid of the bidders. Ten minutes time will be allowed to bidders to quote successive higher bid and if no higher bid is offered by any bidder within ten minutes to the last highest bid, the e-auction shall be closed.
10. Intending bidders are advised to properly read downloaded Sale Notice, Terms & Conditions of e-Auction, Help Manual on operational part of e-Auction and follow them strictly.
11. The successful bidder shall have to deposit full bid amount within 15 days from the date of auction. In case of failure to deposit the amount within the time as stipulated, the amount deposited by successful bidder EMD will be forfeited by Falta SEZ Authority and Falta SEZ Authority shall have the liberty to cancel the auction and conduct a fresh auction.
12. If the successful bidder is an outside entity, they have to vacate the Land within 90days from the date of Sale Order. If they want to sale to other unit inside the Zone they are allowed.
13. If the successful bidder belongs to the FSEZ, it will have first right of rejection for the allotment of the land on which the assets under auction stands.
14. Auctioned materials may be taken out of FSEZ after payment of applicable Duties/Taxes to Customs/FSEZ. The details of applicable Duties/Taxes may be ascertained from Customs/FSEZ.
