6. For the purpose of participation in the e-Auction, the intending bidder must have availed Digital Signature Certificate (DSC-Class III & above). Any intending bidder, presently not having DSC may procure it from any Licensed Certifying Authority authorized under Section 24 of the Indian I.T. Act 2000 (CA).
7. E-Auction will be conducted on **12.05.2026 at 11:30 Hrs to 12:30 Hrs** with 10 extensions of 5 minutes each.

During the e-auction bidders will be allowed to offer higher bid in inter-se bidding over and above the last bid quoted and the minimum increase in the bid amount to the last higher bid of the bidders. Five minutes time will be allowed to bidders to quote successive higher bid and if no higher bid is offered by any bidder within five minutes to the last highest bid, the e-auction shall be closed.
