M/s. Ostern Pvt. Ltd., a unit in FSEZ has applied for renewal of LOA No. FSEZ/LIC/O-8/2012/150 dated 09.04.2012. The matter of renewal of LOA for de-boding purpose has been earlier placed before the 124th UAC meeting held on 18.11.2020 and the LOA of Unit was renewed w.e.f. 16.11.2020 for period of (six) 6 months. Subsequently, their LOA expired on 16.05.2021 and Unit's request for renewal for another 1(one) year i.e. w.e.f.17.05.2021 to 16.5.2022 was approved in the 134th UAC meeting held on 29.09.2021, exclusively for de-bonding purpose. Since, their said LOA extension also expired on 16.05.2022, now the unit has requested for renewal of their LOA for a further period of one year w.e.f.17.05.2022 to 16.5.2023 for completion of de-bonding process.

In this context, it is to be mentioned that an appeal is lying before the Commissioner of Customs (Appeal), Custom House, Kolkata and the Customs, FSEZ vide their ISN dated 25.05.2021 issued from Customs Wing, it has been pointed out that at the time of debonding (Exit of the Unit), the unit should be required to furnish total Bank Guarantee equivalent to the outstanding confirmed dues of **Rs.1,30,16,067/-** or as determined on recalculation of Interest amount. The unit rather chose to wait for the outcome of their Appeal lying before the Commissioner of Customs (Appeal), Custom House, Kolkata, than to furnish BG of such amount. The unit has already removed their assets (capital goods) by furnishing BG equivalent to market value of such goods and is presently not doing any activity from Falta SEZ. FSEZ, Customs has stated in Noting/ Page 67 that their LOP needs to be kept alive for awaiting outcome of their Appeal.

In terms of Rule 19(6A)(3), the Development Commissioner may renew the LOA for a period of 5(five) years or for a shorter period.

The 146thUAC in its meeting held on 27.06.2022 has directed to M/s.Carbide Cutting Tools Pvt. After due examination, the matter will be taken in the next UAC.

Therefore considering the claim of the Unit of the Unit for duty free availment of services featuring in the default list of 66 services, may be placed before UAC for approval in principle, with condition that the services would be endorsed by Customs subject to such invoices bearing necessary details including 3 mandatory details i.e. , proper description of services provided with the amount charged for the services, GSTIN of the service provider, LUT execution details of the service provider.

M/s. Rohit Export Jewellery LLP, having their registered office at "22, Abanindranath Thakur Sarani, Unit A-2 (III), Block-A, 2nd Floor, Kolkata-700017" had been permitted vide Letter of Permission No. MSEZ/LIC/R-1/2004/2296 dated 28.06.2004 for manufacture and export of 'Plain Gold JewelleryStudded/ Un-Studded with precious & non – precious stones' in Manikanchan Special Economic Zone. The Bond cum Legal Undertaking (BLUT) has been executed on 01.11.2004 which was communicated to the unit vide this office letter dated 04.11.2004. The date of commencement of production (DCP) as stated by unit was 14.11.2005.

In terms of provision 22(3) of SEZ Rules, 2006 read with condition No.7 of the Bond-cum-LUT as executed, Annual Performance Report duly certified by Chartered Accountant is required to be submitted within a period of 180 days following the close of financial year in the Form-I to the Office of the Development Commissioner and based on the Annual Performance Report, monitoring is to be done by the Approval Committee in terms of Provision 54 of SEZ Rules, 2006.

It is observed that the unit has submitted its Annual Performance Report (APR) for the year 2015-16 & 2016-17 vide their letter dated 04.11.2020, i.e. not within the prescribed period, which is a clear case of violation of terms and conditions in the LOP/LUT read with SEZ Rules. The unit has also not performed any activities during period thus, non-utilisation of the Govt. SEZ premises allotted to them. The same has been taken into the proceedings of 126th UAC meeting (Agenda No.9) held on 25.01.2021. After due deliberation, the Committee decided to issue a SCN.

As per UAC's directions, this office issued an SCN No.MKSEZ/LIC/R-1/2004/655-657 dated 10.02.2021 for non-performance of the unit and non-utilisation of the Govt. premises. The LOP of the unit expired on 13.02.2017, and the unit has not applied for renewal of LOP. The unit was also given Personal Hearing on 09.08.2021 and 03.09.2021 to appear before the Development Commissioner, FSEZ, but no one appeared.

Further, WBIDC being the Developer has also issued a Show Cause Notice No. WBIDC/IP/MK/SDF 1(SW)/2688 (1) dated 28.08.2020 by the Executive Director, WBIDC stating that since the LOP of the Unit got expired on 13.02.2017, requested the unit to surrender the Module. Finally, WBIDC vide their letter No. WBIDC/IP/MK/SDF 1(SW)/3341 (1) dated

27.01.2021 terminated the Lease of Module No.1-SW allotted to them. The outstanding dues regarding O&M charges upto June 2020 has been calculated by WBIDC as Rs.3,80,054/-.

Now, CRAD Audit Party-IV while conducting Audit of the units in Manikanchan SEZ have raised the issue vide Audit observation reference #2 (OBS-304949) that Adjudication Process shall be carried out immediately.

In view of the above situation, the matter is placed before UAC to take a decision regarding cancellation of the LOP of the unit.
