(The matter was earlier placed before the 187th / 2nd UAC for Nagaland SEZs held on 29.11.2024. The Committee deferred the matter for four weeks for compliance of the observations made.)

Agenda Item No. 190/03.1: Ratification of the minutes of the 187th / 2nd Unit Approval Committee meeting for Nagaland SEZs, held on 29.11.2024.

Minutes of the 187^{th} / 2^{nd} UAC meeting for Nagaland SEZs was circulated to all the members of the Committee. As no comments were received, the 190^{th} / 3^{rd} UAC for Nagaland SEZs ratified the minutes.

Agenda item no. 190/03.2: New Unit Application for Manufacturing Unit in Nagaland Industrial Development Corporation SEZ, Ganeshnagar, Nagaland by M/s Indi Dent Private Limited

Ms Raisha physically represented the applicant before the Committee.

Earlier the matter was placed before the 187^{th} / 2^{nd} UAC meeting for Nagaland SEZs held on 29.11.2024. Following observations were made by the 187^{th} / 2^{nd} UAC:

- From the application it appears that the proposal/project envisages Foreign Direct Investment, however the %age share of FDI is not mentioned in the application. The unit may be requested to provide the details and %age share of FDI. Also, necessary Rule position w.r.t. the same may be examined and placed before the committee.
- 2) The policy for import/export w.r.t. the ITC HS Codes of the products proposed to be manufactured to be checked and placed before the Committee.
- 3) The representative of the unit mentioned that there will be some investment in imported capital goods and RM. The unit may be requested to submit the details of the same.
- Commissioner Customs, North East Region sought time of 4 weeks for antecedent verification and ground report of the SEZ.

Point wise clarifications w.r.t. observations of the 187th /2nd UAC meeting for Nagaland SEZs held on 29.11.2024 are as follows:

- From the application it is not clear whether it involves Foreign Direct Investment or not- Yes, FDI involved (Foreign Holding 99% and Resident Holding 01%).
- 2) The shareholding pattern of the company is also not clear -

3) It also needs to be checked whether any clearance is required for FDI for unit-

Not required. FDI pertaining to the manufacturing sector, falls under the automatic route as per the DPIIT policy (DPIIT's Consolidated FDI Policy, effective October 15,2020). Investments in this sector do not require prior approval from Government of India. (Clarification received from the DoC in this regard vide e-mail message dated 10.02.2025)

4) The application needs to be rectified with reference to the import of capital goods/raw materials-

Investor has ratified that the Capital Goods and raw material will be imported.

- 5) It was desired by the Commissioner Customs, North East Region that four weeks' time may be given for background check of the Indian Director/Company registered by RoC.
 - The four weeks' time elapsed on 01.01.2025.

Accordingly, the matter was again placed before the 190^{th} / 3^{rd} Unit Approval Committee (UAC) Meeting held on 13.02.2025 for deliberation and decision.

In the meeting, it was observed by Shri Lakshmi Kanta Halder, Jt. Director General of Foreign Trade, representing Addl. DGFT, Kolkata, that the financial projections of the entrepreneur does not appear to be economically viable and the project proponent may be requested to furnish the clarifications in this regard.

The representative of the project proponent was given instructions to provide the requisite clarification at the earliest.

Accordingly, the said UAC meeting was deferred for another two weeks for obtaining additional inputs from the applicant Unit and taking further decision. The next date of UAC will be intimated soon.
