Minutes of 144th meeting (4th meeting of the 2022 Series) of the Unit Approval Committee Constituted in terms of Section 13 of Sub Section 1 of the Special Economic Zone Act, 2005 held on 28.04.2022 at 3.00 PM in the chamber of Development Commissioner, Falta Special Economic Zone, 4th floor, 2nd MSO Building, Nizam Palace, 234/4, AJC Bose Road, Kolkata-700 020 through Video Conferencing regarding Falta SEZ, MKSEZ, Candor Kolkata, Wipro IT/ ITES SEZ and DLF IT/ITES SEZs. Ms. Anindita Sengupta, Chairman & CEO welcomed all the members present in the meeting and requested Shri M.K. Anjanaiah, Dy. DC, Falta SEZ to place the agenda before the Committee for discussion.

Item wise decisions taken were as under:

Agenda Item No. A&B: Ratification of the minutes of 143th UAC meeting held on 21.03.2022.

Minutes of the 143th UAC meeting was circulated to all the members of UAC. As no comments were received, the committee ratified the minutes and confirmed the same.

Agenda Item No.1: Request of M/s. Eastern Silk Industries Ltd., a Trading Unit for renewal of LOP No. FEPZ/LIC/E-11/1998/4889 dated 14.10.1998 for a further period of 5 years w.e.f. 25.03.2022.

The request M/s. Eastern Silk Industries Ltd., a Trading unit in Falta SEZ for renewal of LOA No. FEPZ/LIC/E-11/1998/4889 dated 14.10.1998 was discussed and thoroughly examined by the Committee Shri Radha Mohan Binani appeared before the Committee on behalf of the unit through Video Conferencing during the course of discussion in the UAC and requested their proposal for consideration. The committee noted that the unit has pending combined rental dues amounting to Rs. 53,92,591/- for the quarter ending March, 2022 for both manufacturing and Trading unit. It was informed by the Approval Committee that the unit has a few activities during the pre-covid period and the same is clarified by the unit due to their fund crisis in the pandemic period. However the unit concerned has assured the Committee for better performance as per projected Forex Balance Sheet in the next block as submitted in their application.

After due deliberation, the Committee informed to the concerned unit to submit all necessary documents, including rent paid receipts so that decision can be taken in this respect.

The request for United Sales Agency, a Trading unit of Falta SEZ for renewal of their Letter of Approval NO. FSEZS/LIC/U-14/2006/3282 dated 31.08.2006 for a further period of 5 years was discussed and examined by the Committee. Shri Subir Ghosh appeared before the Committee on behalf of the unit through Video Conferencing during the course of discussion in the UAC and requested their proposal for consideration. The committee noted that the unit has no rental dues pending up to the period of 31.03.2022 and due to ongoing covid-19, the unit have not submitted for renewal of their LOA in time and apologized for it. The Committee also observed that cumulative NFE of the unit is very good and up to the mark.

After due deliberation, the Committee decided to approve their proposal for renewal of their LOA No. FSEZ/LIC/U-14/2006/3282 dated 31.08.2006 in view of past performance and future project Forex Balanced beyond 27.12.2021 in terms of Rule 19(6A)(3) of SEZ Rules, 2006 subject to compliance of SEZ Act,2005 & SEZ Rules 2006 as requested by the unit.
