Minutes of 159<sup>th</sup> meeting (4<sup>th</sup> meeting of the 2023 Series)of the Unit Approval Committee constituted in terms of Section 13 of Sub Section 1 of the Special Economic Zone Act, 2005 held on 31.03.2023 at 3.30 P.M. in the chamber of Development Commissioner, Falta Special Economic Zone, 4<sup>th</sup> floor, 2<sup>nd</sup> MSO Building, Nizam Palace, 234/4, AJC Bose Road, Kolkata-700020 through Video Conferencing regarding Falta SEZ, ManikanchanSEZ, Candor Kolkata One Hi-tech Structures Ltd. IT/ITES SEZ, Wipro Ltd. IT/ ITES SEZ and DLF Ltd. IT/ITES SEZs. List of participants is enclosed at Annexure-I.

Smt. Satish Kumar, Chairman & CEO welcomed all the members present in the meeting and requested Shri M.K. Anjanaiah, Dy. Development Commissioner, Falta SEZ to place the agenda before the Committee for discussion.

**Item wise decisions taken were as under:**

**Agenda Item No. A&B:** Ratification of the minutes of 158<sup>th</sup> UAC meeting held on 16.03.2023.

Minutes of the 158<sup>th</sup> UAC were circulated to all the members of UAC. As no comments were received, the committee ratified the minutes and confirmed the same.

**Agenda Item No.2:** Request by M/s. Natural Product Manufacturers for setting up of a new Unit at Falta Special Economic Zone, Falta, South 24 Parganas for manufacturing and export of Shellac (Dewaxed Bleached Shellac), ISO Ambrettolide and Aleuritic Acid - regarding

The proposal of M/s. Natural Product Manufacturers for setting up of a manufacturing unit at Falta SEZ, Falta, District: South 24 Pargana, West Bengal for manufacturing and export of Shellac (Dewaxed Bleached Shellac), ISO Ambrettolide and Aleuritic Acid was discussed and examined by the Committee. Shri Sumit Kumar Ghosh, Partner appeared before the Committee physically on behalf of the company and requested for consideration of their proposal. The Committee asked the unit about their raw materials requirements and products to be manufactured. The same was clarified by the unit. The Committee enquired

from the unit about FSSAI and West Bengal Pollution Control Board (WBPCB) clearances. The unit confirmed that they will adhere to all the extant norms of FSSAI and WBPCB.

The Committee found some mismatches among the figures furnished under the heads 'Import and Indigenous requirement of materials and other inputs', 'FOB value of exports during the first 5 years' and 'Foreign Exchange outgo for the first 5 years'. The unit clarified that their total FOB value of export for the first 5 years will be Rs 1000 Crores, and for the first 5 years they will require Rs 375 Crores of imported raw materials & Rs 191 Crores of indigenous raw materials. The unit informed in the meeting that they will submit corrected figures at the earliest.

After due deliberation, the Committee decided to approve the proposal of the unit for setting up of a new unit for manufacturing of Shellac (Dewaxed Bleached Shellac), ISO Ambrettolide and Aleuritic Acidat at Falta SEZ, in terms of Rule 18 of SEZ Rules, 2006, subject to their submission of revised/matching figures.

This issues with the approval of Development Commissioner.
