Subject: Minutes of the 180th Unit Approval Committee (UAC) meeting (7thmeeting of the 2024 Series) held on 24.07.2024 at Manikanchan Special Economic Zone, Kolkata under the chairmanship of Zonal Development Commissioner.

Agenda item no. 180.1: Ratification of the minutes of the 178thMeeting of the Unit Approval Committee held on 12thJune, 2024.

Minutes of 178thUAC meeting was circulated to all the members of the Committee. As no comments received from the members, the Committee ratified the minutes.

Agenda item no.180.2 (i) :Application of M/s. Binit Traders for setting up of a new Trading Unit at Falta Special Economic Zone, Falta, West Bengal.

ShriBinitJaiswal, Proprietor, physically represented the applicant before the Committee.

Committee considered the matter in light of Rule 18 of the Special Economic Zones Rule, 2006.

Committee observed that, the proposed items for trading i.e. Fire Extinguisher, Fire Alarm System and Fire Detection System are not prohibited items as per extant Indian Trade Classification (Harmonized System) of Export and Import Items.

After deliberationCommittee approved the subject proposal, and notedthe projected FOREX balance sheet for five years (Rs15.50crores exports, cumulatively, with zero imports), proposed investment of Rs1.00 lakh in plant & machinery and proposed employment of 07 people (with 02 women).

Agenda No.180.2 (ii) :Request for inclusion of additional item "Concrete Paver Block" (HSN Code 68101110) in existing LOA No. FSEZ/LIC/H-20/2015/2026 dated 30.09.2015 by M/s. Harveen Veneer Pvt. Ltd.

ShriVinayphysically represented the unit before the Committee.

Committee considered the matter in light of Rule 26 of the Special Economic Zones Rule, 2006.

Committee observed that the proposed itemof exporti.e. Concrete Paver Blockis not prohibited item as per extant Indian Trade Classification (Harmonized System) of Export and Import Items.

Unit stated before Committee that their exports will increase upon inclusion of the said item.

After deliberation, Committee approved the subject proposal and the unit was advised to submit their revised (increased) FOREX balance sheet.

Agenda No.180.2(xii): Application of M/s. Tradeflux Interbiz India Pvt. Ltd. for setting up of a new Service Unit at Falta Special Economic Zone, Falta, West Bengal.

Shri Pervez Kadri virtually represented the applicant before the Committee.

Committee considered the matter in light of Rule 18 of the Special Economic Zones Rule, 2006.

Committee observed that unit has applied for Service unit, whereas their proposed activity is repairing/assembling of electronic goods which comes under the ambit of Manufacturing u/s 2(r) of the Special Economic Zones Act, 2005.

After deliberation Committee decided to reject the application due to the said mismatch in application. And the unit was advised to apply afresh for manufacturing unit.

Agenda No.180.2(xiii): Request for approval of Default List of Services for authorized operation at Falta SEZ by M/s. Himadri Speciality Chemical Ltd.

Shri Ashok Mishra physically represented the unit before the Committee.

Committee considered the matter in light of the instructions issued by SEZ Division, Department of Commerce in this regard.

And i.r.o. rest of the requested services, Committee decided to give 'in principal' approval to the request of unit. Formal approval would be given only after unit submits required documents to establish that the requested services are getting availed by them in the SEZ.
