

Agenda Item No. 181/68.1: Ratification of the minutes of the 179/67th UAC held on 01.07.2024 for Odisha.

Minutes of the 179/67th UAC meeting was circulated to all the members of Committee. As no comment received, the committee ratified the minutes.

Agenda Item No. 181/68.2: Application of M/s. ACME Clean Energy Private Limited for setting up of a new Manufacturing Unit at Tata Steel SEZ, Gopalpur, Odisha.

Shri Darshan Joshi and Shri Abhishek Gupta physically represented the applicant before the Committee.

Committee considered the matter in light of Rule 18 of the Special Economic Zones Rules, 2006.

The Committee after due deliberation approved the subject proposal.

Committee noted the FOREX balance sheet for five years (Rs. 13,448.41 crores exports and Rs 1,257.05 crores Net Foreign Exchange earnings, cumulatively), proposed investment of Rs 11,419.95 crores in plant & machinery and proposed employment of 420 people (with 42 women).
