Subject: Minutes of the 198th / 2nd Unit Approval Committee (UAC) Meeting for the SEZs of Jharkhand held on 30.07.2025 through video conferencing under the chairmanship of Zonal Development Commissioner, Falta Special Economic Zone.

Agenda item no. 198/02.1: Change of name in terms of Court approved merger (NCLT) of M/s Adani Power (Jharkhand) Limited, Godda, Jharkhand after amalgamation.

Mr. Jigar Dalal, Mr. Sanjay Dhingra and Mr. Nimit Mehta virtually represented the Developer/Unit before the Committee.

Committee observed that,

- Hon'ble NCLT vide its order dated 04.04.2025 has sanctioned the scheme of amalgamation of Adani Power (Jharkhand) Limited ("Transferor Company") with Adani Power Limited ("Transferee Company").
- The Company has undertaken that they shall not opt out or exit out of the SEZ and continue to operate as a going concern and shall follow all the safeguards as per Instruction Order No. 109 dated 18.10.2021 of the Department of Commerce.

After deliberation, Committee noted the amalgamation of Adani Power (Jharkhand) Limited with Adani Power Limited in terms of Instruction Order No. 109 dated 18.10.2021 of the Department of Commerce and approved change of name in the LoAs and other documents accordingly w.r.t. the Developer and Unit w.e.f. the date of NCLT Order i.e. 04.04.2025 subject to the condition that all liabilities of the Developer / Co-developer / Unit shall remain unchanged on such reorganization.
