Minutes of the 206th meeting of the Unit Approval Committee (UAC) for the State of Odisha, held on 27.01.2026 in the O/o Development Commissioner, Falta Special Economic Zone, Kolkata, under chairmanship of the Development Commissioner.

Agenda Item No. 206.1: Ratification of the Minutes of the 199th/72nd Meeting of the Unit Approval Committee held on 18/08/2025

Minutes of the 199/72nd UAC meeting were circulated among all the Members. As no comments were received from any Member, the Committee ratified the minutes and confirmed the same.

Agenda Item No. 206.2: Demerger of aluminum undertaking of Vedanta Limited into wholly owned subsidiary Vedanta Aluminum Metal limited

Mrs. Kritashna More from VAML and Mr. Shalendra Thakur from Vedanta Ltd virtually represented the Developer/unit before the Committee.

Committee observed the following:

1. Hon'ble NCLT vide its Order dated 16.12.2025 has sanctioned the scheme of demerger of the aluminum undertaking of Vedanta Limited into wholly owned subsidiary Vedanta Aluminum Metal Limited.
2. The Company has undertaken that they shall not opt out or exit out of the SEZ and continue to operate as a going concern and shall follow all the safeguards as per the Instruction Order No. 109 dated 18.10.2021 of the Department of Commerce, Ministry of Commerce & Industry, Government of India.

After deliberation, Committee noted the demerger of the aluminium undertaking of Vedanta Limited into its wholly owned subsidiary, Vedanta Aluminum Metal Limited, in terms of Instruction Order No. 109 dated 18.10.2021 of the Department of Commerce and approved change of name in the LoAs and other documents accordingly w.r.t. the Developer and Unit w.e.f. the date of NCLT Order i.e. 16.12.2025, subject to the condition that all liabilities of the Developer/Co-developer/Unit shall remain unchanged on such reorganization.

Agenda Item No 206.3: Request from M/s Infosys Ltd for merger of its Unit-II into Unit-I of Infosys Limited, Odisha, located in Info Valley, IDCO IT/ITES SEZ, Gandamunda & Arisal, Bhubaneswar, Odisha.
