The representative of the company informed the Committee that the proposed FTWZ unit would be engaged in import of goods, warehousing, and distribution of items intended for export or re-export.

Committee considered the matter in terms of Rule 18 and Rule 26 of the Special Economic Zones Rules, 2006 and the following were observed:

1. The items will be subjected to the policy conditions specified in DGFT's ITC HS Code wherever applicable.
2. In case of any discrepancies/mismatch between the 'Description of Goods' as provided by the unit and 'Description of goods' as per DGFT Import policy, the later will prevail
3. The items falling under ITC(HS) Codes 84129090, 84679900, 84819090, 84823000, 84831099, 84832000, and 84834000, relating to vintage motor cars and vintage motorcycles, including their parts and components, are classified as restricted items for export.

After due deliberations, the Committee approved the Proposal.

- 2) As per Section 15(1) r/w Section 2(v) of SEZ Act, 2005 a company whether incorporated in India or outside India may set up a unit in a SEZ.
- 3) The applicant vide undertaking dated 22.01.2026 has submitted that the project does not involve Foreign Collaborations or Foreign Direct Investments.
- 4) The project envisages NFE earnings of Rs. 37760.10 lakhs in 5 years, investment of Rs. 585.99 lakhs in Plant & Machinery and Employment of 512 people.

After due deliberations, the Committee approved the Proposal.
