Minutes of 206<sup>th</sup> UAC meeting was circulated among all the members of the Committee. As no comments were received from any Member, the Committee ratified the minutes and confirmed the same.

**Agenda Item No.210.2: Request for inclusion of one additional item that is "Touch Ferro Chrome"(HSN code: 72024900) in the existing LOA No. SEZ/LOA/E-1(Odisha)/2019/1514 dated 26.07.2019 of M/s East Coast Overseas Pvt. Ltd.**

Shri Prasant Kumar Jena virtually represented the unit before committee.

The unit has proposed for inclusion of one additional item that is "Touch Ferro Chrome"(HSN code: 72024900) in the existing LOA No. SEZ/LOA/E-1 (Odisha)/2019/1514 dated 26.07.2019. The unit stated that its exports are expected to double after inclusion of the proposed item.

It was observed that as per the prevailing Foreign Trade Policy (FTP) provisions and ITC (HS) classification, the said item is categorized as "Free" for export, subject to compliance with applicable regulations and provided it does not fall under any prohibited or restricted category.

The Committee approved the proposal in terms of 1<sup>st</sup> Proviso of Rule 19(2) of the Special Economic Zone Rules, 2006.
